#### 6. CONSIDERATION OF CLAUSES

### 6.1. Payment of Members' Expenses (Amendment) Bill 2018 – Clauses considered

Mr Cregeen to move.

**The Speaker:** Item 6, Consideration of Clauses, Payment of Members' Expenses Bill 2018, and I call on the Hon. Member for Arbory, Castletown and Malew to move.

Mr Cregeen: Thank you, Mr Speaker.

At the Second Reading I reminded the House that the Standing Orders Committee of Tynwald reported on the suspension of Members in May and incorporated this Bill in its report. Tynwald agreed unanimously that this Bill be brought before the House of Keys to amend the law to provide for the loss of expenses as defined in the Payment of Expenses Act 1989, including any additional sums payable to certain office holders.

The House agreed the Second Reading of this Bill a fortnight ago without division. The Bill deals with the circumstances where a Member is called on to apologise for misconduct and refuses to do so and is suspended until he or she complies with the Orders of Tynwald. It is a Bill with only two clauses which, with the leave of this House, I shall move together.

**The Speaker:** Is that agreed, Hon. Members? (**Members:** Agreed.) Mr Cregeen.

**Mr Cregeen:** Thank you, Mr Speaker; thank you, Hon. Members.

Clause 1 provides for the short title of the resulting Act. It will come into operation on the day on which Royal Assent is announced.

Clause 2 amends the Payment of Members Expenses Act 1989. The newly inserted section 7A will prevent a Member who has been suspended from Tynwald, or either Branch, from receiving any payment under sections 2, 3 or 4 of that Act and from receiving any additional payment under section 1(2) of that Act in respect of the period of suspension.

I beg to move.
