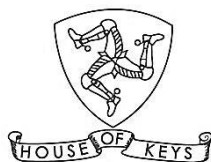

What action Government Departments, Boards and Offices are taking to reduce their consumption of single use plastic; and what targets have been set in this regard?

2. The Hon. Member for Onchan (Ms Edge) to ask the Minister for the Treasury –

Under what policy off-Island construction companies are regulated for tax purposes?

3. The Hon. Member for Onchan (Ms Edge) to ask the Minister for Policy and Reform –

Whether minutes are taken at Chief Officer Group meetings?

4. The Hon. Member for Onchan (Ms Edge) to ask the Minister for Policy and Reform –

If he will provide an update on the Civil Service size and structure review; and whether the contract has been awarded?

5. The Hon. Member for Douglas Central (Mrs Corlett) to ask the Minister for Policy and Reform –

What consideration has been given to bringing forward legislation to prevent the public display of offensive graphic material?

6. The Hon. Member for Ramsey (Dr Allinson) to ask the Minister for Education, Sport and Culture –

What extra provision his Department is planning to put in place following the decision by the Children's Centre to end its Early Years Services?

What contraceptive services, including condoms, are provided to the Island's sixth formers and to students at University College Isle of Man?

How many children are currently waiting to be adopted; how many children are in foster care; and how both groups will be affected by the Children's Centre's decision to end its Family Placement Service?

What records his Department keeps of the numbers of prescriptions issued for emergency contraception, and of the number of times emergency contraception is supplied directly by pharmacists?

If he will reaffirm the commitments made regarding the proposed service changes and long term future of Ramsey and District Cottage Hospital?

How many educational visits from island schools were there to (a) East Asia; and (b) the USA in the last five years; and how many are planned for 2018?

Whether, in light of the agreed external review of the Health Service, he is still committed to implementing the policies set out in the Programme for Government?

2. The Hon. Member for Onchan (Ms Edge) to ask the Minister for Policy and Reform –

In each of the last five years (a) how much has been spent on the digital strategy; (b) which projects have been implemented and delivered and how much has each of these cost; and (c) what future projects, with costs, are currently budgeted for?

3. The Hon. Member for Middle (Mr Shimmins) to ask the Minister for Home Affairs –

How the Island ranks alongside the 78 counties of England, Scotland and Wales in the Road Crash Index produced by the Road Safety Foundation?

4. The Hon. Member for Onchan (Mr Callister) to ask the Minister for Infrastructure –

Pursuant to his Written Answer of 16th January 2018, if he will provide a breakdown of (a) total net income from lettings (£17.31M); (b) total revenue costs (£6.63M); (c) operational surplus (£10.68M); (d) interest costs on existing loans (£6.48M); and (e) capital repayments (£9.34M)?

How much waste was incinerated at the Energy from Waste Plant in 2016/17 in (a) the primary incinerator; and (b) the secondary incinerator?

7. The Hon. Member for Ramsey (Mr Hooper) to ask the Minister for Infrastructure –

If he will provide: (i) the date on which Tynwald approved his Department's 'pay to stay' housing policy; (ii) the date the policy was approved by him; (iii) the date the policy came into force; (iv) the dates of the consultation period with housing authorities on the 'pay to stay' concept; and (v) a summary of responses from each of the housing authorities in respect of the 'pay to stay' policy?

8. The Hon. Member for Ramsey (Mr Hooper) to ask the Chairman of the Manx Utilities Authority –

What the cost was of dealing with the seawater contamination in Douglas in December 2017; and whether any compensation was or will be paid by those responsible?
