(1) That Tynwald calls upon the Council of Ministers to acknowledge and recognise the national importance and significance of the 'Chronicles of Mann', being probably the most important document in Manx History, that it is a 'Manx Document' pertaining solely to the Island.

(2) That negotiations through relevant channels and with relevant parties, if commenced should continue and be built upon with a greater urgency, and if not commenced, then be established as soon as possible with the aim, in both cases, of ultimately having the 'Chronicles' returned to the Isle of Man.

66. Regional Television -

The Hon Member of the Council Mr Turner to move -

Tynwald is of the opinion that -

- (a) Should Border ITV merge with the Tyne-Tees ITV region, the Isle of Man should be serviced by ITV Granada, thus receiving a North West ITV service, similar to that provided by BBC Manchester, and
- (b) Any regional TV service provided by ITV or BBC should be part of the North West region, not the North East and
- (c) The Government should make appropriate representation to ITV and relevant UK Authorities in an endeavour to secure such an ITV service for the Island.

67. Depositors' Compensation -

The Hon Member for Michael (Mr Cannan) to move -

That Tynwald requests the Financial Supervision Commission together with the Treasury to review and if necessary amend the Isle of Man Depositors' Compensation Scheme, the Financial Supervision Act 1988, and the Banking Business (Compensation of Depositors) Regulations.

68. Maladministration in the planning processes in connection with the 'Poachers Pocket' development at Ballasalla

The Hon Member for Malew & Santon (Mr Cregeen) to move-

That a Committee of three Members be appointed, with powers to take written and oral evidence pursuant to sections 3 and 4 of the Tynwald Proceedings Act 1876 as amended, to investigate all matters related to the handling of planning application 02/0712, in particular by the Department of Local Government and the Environment, and notably:

- (i) the failure of the Department to advertise various amendments to the main application, subsequently the subject of condition 19, or to advertise further applications which were made pursuant to that condition;
- (ii) the use by the Director of Planning and Building Control of delegated powers to approve major changes which it is claimed should have been the subject of a formal and advertised application determined by the Planning Committee, as required by the explicit wording of condition 19;

(iii) the use by the Director of Planning and Building Control of delegated powers to approve major changes in relation to the development without reference to the Planning Committee, when he had previously acted in the same matter as an advocate before the Committee who reached conclusions different from those in the Director's later approvals;

and to report with recommendations by the March 2008 sitting of the Court.

69. Departure of the Present Chief Constable -

The Hon Member for Douglas North (Mr Houghton) to move -

That Tynwald welcomes the opportunity provided by the departure of the present Chief Constable for the ethos and management of policing in the Island to be reassessed.

70. Announcement of Royal Assent -

Education (Amendment) Act 2007

(subject to Royal Assent being notified)
