### PASTORAL MEASURE 1983

#### MAUGHOLD AND SOUTH RAMSEY PASTORAL SCHEME 2012

Coming into operation

1st October 2012

The Church Commissioners for the Isle of Man make this Scheme under sections 8, 17, 19, 27, 31 and 32 of the Pastoral Measure 1983<sup>1</sup>, as it has effect in the Isle of Man<sup>2</sup>, and with the consent of the Lord Bishop of Sodor and Man.

#### 1. Title

The title of this Scheme is the Maughold and South Ramsey Pastoral Scheme 2012.

## 2. Commencement

This Scheme shall come into operation on 1st October 2012.

# 3. Union of benefices and parishes

- (1) A new benefice, named the benefice of Maughold and South Ramsey, is hereby created by the union of the benefices of Maughold and South Ramsey (otherwise St Paul, South Ramsey).
- (2) A new parish, named the parish of Maughold and South Ramsey, is hereby created by the union of the parishes of Maughold and South Ramsey (otherwise St Paul, South Ramsey).
- (3) The area of the new benefice created by paragraph (1) is the new parish created by paragraph (2).
- (4) The right to present the vicar to the new benefice created by paragraph (1) shall be exercised by Her Majesty The Queen and the Lord Bishop of Sodor and Man alternately, Her Majesty having the first turn.

- (5) The new parish created by paragraph (2) shall belong to the deanery of Ramsey.
- (6) The church or chapel of Christ Church, Dhoon is designated as an additional parish church of the new parish created by paragraph (2).
- (7) The chapelry or district assigned to the church or chapel of Christ Church, Dhoon shall cease to exist and the parochial church council of that chapelry or district is dissolved.
- (8) The parsonage house of the benefice of St Paul, South Ramsey known as St Paul's Vicarage, at Walpole Drive, Ramsey shall be the parsonage house of the new benefice created by paragraph (1).
- (9) The parsonage house of the benefice of Maughold, known as Maughold Vicarage, is hereby transferred to the Sodor and Man Diocesan Board of Finance to be held by the Board for disposal in accordance with paragraph 9 of Schedule 3 to the Pastoral Measure 1983, as it has effect in the Island.
