# **SOUTHERN PASTORAL SCHEME 2012**

Coming into operation

1st February 2013

The Church Commissioners for the Isle of Man make this Scheme under sections 8, 17, 19, 31, 32 and 39 of the Pastoral Measure 1983<sup>1</sup>, as it has effect in the Isle of Man<sup>2</sup>, and with the consent of the Lord Bishop of Sodor and Man.

### 1. Title

The title of this Scheme is the Southern Pastoral Scheme 2012.

## 2. Commencement

This Scheme comes into operation on 1st February 2013.

## 3. Arbory and Castletown

- (1) A new benefice, named the benefice of Arbory and Castletown, is hereby created by the union of the benefices of Arbory and Castletown.
- (2) A new parish, named the parish of Arbory and Castletown, is hereby created by the union of the parishes of Arbory and Castletown, with the addition of the detached part of the parish of Malew lying to the south-west of the parish of Castletown.
- (3) The area of the new benefice created by paragraph (1) is the new parish created by paragraph (2).
- (4) The right to present the vicar to the new benefice created by paragraph (1) shall be exercised by Her Majesty The Queen and the Lord Bishop of Sodor and Man by turns, the first turn to be exercised by Her Majesty.
- (5) The parsonage house of the benefice of Castletown, known as Castletown Vicarage, Arbory Street, Castletown, shall be the parsonage house of the new benefice created by paragraph (1).

### 4. Malew and Santan

- (1) A new benefice, named the benefice of Malew and Santan, is hereby created by the union of the benefices of Malew and Santan.
- (2) A new parish, named the parish of Malew and Santan, is hereby created by the union of the parishes of Malew (except the detached part referred to in clause 3(2)) and Santan.
- (3) The area of the new benefice created by paragraph (1) is the new parish created by paragraph (2).
- (4) The right to present the vicar to the new benefice created by paragraph (1) shall be exercised by Her Majesty The Queen.
- (5) The following
  - (a) the church or chapel of Saint Mary the Virgin, Ballasalla (known as the Abbey Church), and
  - (b) the church or chapel of Saint Mark, shall be additional parish churches of the new parish created by paragraph (2).
- (6) The parsonage house of the benefice of Malew, known as The Vicarage, St Mark's Road, Ballasalla, shall be the parsonage house of the new benefice created by paragraph (1).

# 5. Revocation

The Arbory, Santan and Castletown Pastoral Order 2005 is revoked.

# **EXPLANATORY NOTE**

(This note is not part of the Scheme.)

This Scheme creates two new benefices and ecclesiastical parishes —

- (a) Arbory and Castletown, and
- (b) Malew and Santan

by the amalgamation of the benefices and ecclesiastical parishes of Arbory, Castletown, Malew and Santan.
