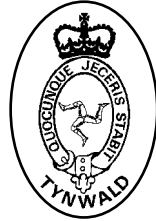

- (b) approves the Department incurring expenditure not exceeding £75,000 for research and to enable the Department to continue its investigations;
- (c) authorises the Treasury to apply from General Revenue during the year ending 31st March, 2000, a sum not exceeding £75,000 being the additional amount required for such research and continued investigations; and
- (d) requests the Department to report with recommendations, to Tynwald no later than the October 2000 sitting.

24. Select Committee on the Petition for Redress of Grievance of Arthur Derek Radcliffe –

The Chairman of the Committee (Mr Speaker) to move -

That the Hon Member of the Council, Mr Waft, be discharged from the Committee, and that Tynwald elect a member to fill the vacancy.

25. The Lieutenant Governor –

Mr Cannan to move -

That Tynwald is of the opinion that the next Lieutenant Governor should be a Manx person or person of Manx descent.

26. Coastal Erosion –

Mr Cannan to move -

That Tynwald –

- (a) supports the recommendations of Posford Duvivier International in their Report on Coastal Erosion at Kirk Michael; and
- (b) is of the opinion that construction of rock armour revetment of the first 200 m from Glen Wyllin to Balleira be implemented commencing April 2000.

That Tynwald is of the opinion that the Chairmen of Village Commissioners (“Village” as defined in Table 2A – Isle of Man Census Report 1996 – Volume 1) should be invited to participate in the sitting of Tynwald at St John’s on Tynwald Day and be seated on Tynwald Hill.

Mr Henderson to move -

That the Council of Ministers consider means of providing ex gratia payments to World War II prisoners of war held by Japan, who are resident in the Isle of Man; and report no later than the June 2000 sitting.

That a Select Committee of three members be appointed to examine and report on the effectiveness of the current Petition for Redress of Grievance procedure and alternative methods of ensuring action in the case of a legitimate grievance.
