4. Excess Expenditure - Department of Health and Social Security -

That Tynwald receive the document by the Chamber of Commerce Tourism Committee "Productivity in the Tourism Sector", a response to the Review of Economic Strategy October 2003 dated January 2004, and that Treasury scrutinize its contents and recommendations and assess the viability of incorporating the recommendations into forthcoming and future Government Strategy in an amended format.

That Tynwald is of the opinion that the Department of Health and Social Security, through its Audiology Department and any additional resources it may require, undertake a local study as to the practicality of introducing digital hearing aid technology on the National Health Service to qualifying patients with hearing difficulties, taking cognizance of any current United Kingdom information, or initial information from any pilot studies, but progress the local study as soon as is practicable.
