In the Isle of Man Government Report, Council of Ministers identified as one of its four priority strategic aims the pursuit of manageable and sustainable growth based on a diversified economy, can you confirm that -

- (a) the words "sustainable growth" reflect not only the need for sustainable growth in economic output but also a more sustainable and manageable approach to growth in public services;
 - (b) without designated officers in each department of Government with responsibility for promoting sustainable development policies, how will this priority strategic aim be achieved; and
 - (c) what difference would you expect people to notice in their day to day lives if your Government is successful in achieving sustainable development?
2. The Hon Member for Douglas North (Mr Houghton) to ask the Minister for Trade and Industry -

When do you intend to hold a presentation to Members of Tynwald on the MEA Broadband Initiative?

3. The Hon Member for Douglas North (Mr Houghton) to ask the Minister for Health and Social Security -

Will you make a public statement on the latest developments with regard to the provision of land by your Department for the construction of the new hospice care facility at Ballamona, Strang?

4. The Hon Member for Douglas North (Mr Houghton) to ask the Minister for Health and Social Security -

Will you take immediate steps to find a replacement for the service to the Diabetic Centre premises provided by Dr Blackman?

5. The Hon Member for Douglas North (Mr Houghton) to ask the Minister for Health and Social Security -

Will you bring amended regulations to the November sitting of Tynwald in respect of Exceptional Needs Grant Payments and, if not, why not?

Why has Manx National Heritage failed to find appropriate accommodation for one of its current Cregneash tenants who has been left in a substandard property for the whole of this Summer?
