*“(4) Without prejudice to subsections (2) and (3), the price for any gas supplied under subsection (1)(b) shall not exceed -*

*(a) the maximum price for the time being specified in a direction under section 37 (maximum prices for reselling gas) of the Gas Act 1986 (an Act of Parliament), or*

- (b) *where more than one such price is for the time being so specified, such of those prices as the Department may from time to time direct by notice in writing to the Authority.*
- (5) *The Department may by order -*
- (a) *fix a maximum price, or*
- (b) *provide for a method of fixing the maximum price, for any gas supplied under subsection (1)(b); and subsection (4) shall have effect subject to any order under this subsection.*
- (6) *An order under subsection (5) shall not have effect unless it is approved by Tynwald.”*

New Clause for agreement in principle -

### **Transport of gas**

The Authority, if requested to do so by a public gas supplier, shall authorise the supplier to convey through any pipe referred to in section 1(2) gas conveyed from any place outside the Island, on such terms and conditions as may be agreed between the Authority and the supplier or, in default of agreement, determined by arbitration.
