4. Select Committee on the Functioning of Tynwald

The Chairman of the Select Committee on the Functioning of Tynwald
(Mr Speaker) to move –

That the Third Report of the Select Committee on the Functioning of Tynwald

Recommendation 1

The Tynwald Management Committee should be responsible for overseeing the Members' Continuous Professional Development Programme.

Recommendation 2

a. The Lord Bishop should retain his vote.

(if the above recommendation is agreed to)

b. Any Member of Tynwald who has a right to vote should be under the same duty to exercise that vote as any other Member; this applies to the Lord Bishop.

(if the above recommendation is agreed to)

c. Any Member of Tynwald who has a right to vote should be under the same duty to attend and count towards the quorum as any other Member; this applies to the Lord Bishop.

Recommendation 3

The basic terms of reference of an inquiry into Members' pay should therefore be:

That Tynwald is of the opinion that the Isle of Man Government should establish an independent review to examine and report on the emoluments of Members of the House of Keys and Legislative Council, including all pay and allowances, with recommendations for a structure for salary and any related payments; and that the review should have regard to the following principles:

- The salary and benefits must be sufficient to allow anyone to be able to serve in Tynwald;
- The salary and benefits must be at a level to attract a diverse collection of community members;
- Enhanced executive and scrutiny roles should be recognized;
- Any change to the structure for pay and allowances must not result in an increase in overall costs of Members' remuneration; and

- The recommendations of the review should maintain the principle of linking Members' basic pay to Civil Service salary levels.
