## DEFENCE OF THE REALM.

### **THE IMPORTED BACON, HAM, AND LARD (WHOLESALE PRICES) ORDER, 1920.**

---

---

HIS EXCELLENCY THE LIEUTENANT-GOVERNOR has issued an Order dated 27th July, 1920 (a copy of which is appended), made under the powers afforded by the Defence of the Realm Regulations, fixing the Maximum Prices at which Bacon, Ham, and Lard may be sold by wholesale in the Isle of Man from 31st July, 1920, until further notice.

The Order revokes the Imported Bacon, Ham, and Lard (Prices) Order, 1919, and thereby **decontrols the Retail Prices of Bacon and Ham.**

Any person acting in contravention of the Order is guilty of a summary offence against the Defence of the Realm Regulations, and is liable to be sentenced to imprisonment, with or without hard labour, for a term not exceeding six months, or to a fine not exceeding £100, or to both such imprisonment and fine.

*TO WIT.* } C.B., Lieutenant-Governor of the said Isle, etc., etc.

In exercise of the powers conferred upon him by the Defence of the Realm Regulations, and of all other powers enabling him in that behalf, the Lieutenant-Governor hereby orders that except under the authority of the Lieutenant-Governor the following Regulations shall be observed by all persons concerned:—

1. (a) A person shall not by wholesale sell or offer or expose for sale or buy or offer to buy any imported bacon, ham, or lard at prices exceeding the maximum prices provided by or by notice under this Order.

Until further notice the maximum prices shall be as follows:—

(b) On the occasion of a sale of imported bacon, ham or lard which is not a sale by retail, prices at the rate set out in the Schedule.

2. The maximum prices prescribed in the Schedule are fixed on the basis that the cost of delivery to the buyer's premises is included in the price and no sales to which the Schedule applies shall be made on any other basis.

3. (a) On the occasion of a sale to which the Schedule applies the terms of sale shall be, at the seller's option, either:—

(i) Payment before delivery, with discount at the rate of 5 per cent. per annum for two months.

(ii) Payment within seven days of the date of invoice, with discount at the rate of 5 per cent. per annum for two months.

(iii) Payment after seven days of date of invoice, with discount at the rate of 5 per cent. per annum for the unexpired portion of two months and three days from date of invoice.

(b) For the purposes of this clause "date of invoice" shall mean the date of despatch of the goods to the buyer, or the date borne by the invoice, whichever shall be the later, excepting in cases where goods are detained pending buyer's instructions, in which case it shall mean the date when the goods were ready for despatch to the buyer.

4. Where on the occasion of a sale other than a sale by retail, the seller provides wrappers or other packing materials, the cost of the same may be charged to the buyer in addition to the prices prescribed under this Order; provided that such cost shall be shown separately on the invoice and shall be refunded in full to the buyer on his returning the wrappers or packing materials to the seller in good condition, fair wear and tear excepted.

5. A person shall not, in connection with any sale or disposition or proposed sale or disposition of any bacon, ham, or lard, enter or offer to enter into any artificial or fictitious transaction or make or demand any unreasonable charge.

6. The expression "bacon" shall include shoulders and picnics, but shall not include pickled pork or cured pig's heads.

7. Infringements of this Order are summary offences against the Defence of the Realm Regulations.

8. This Order shall come into force on the 31st July, 1920.

9. This Order revokes the Imported Bacon, Ham and Lard (Prices) Order, 1919, and thereby decontrols all retail prices of bacon and ham.

10. This Order may be cited as the Imported Bacon, Ham and Lard (Wholesale Prices) Order, 1920.

11. This Order does not affect the Order amending the Imported Bacon, Ham, and Lard (Prices) Order, 1919, fixing the retail price of Lard which remains in force.

#### THE SALE OF WILTSHIRE SIDES.

“On the occasion of the sale of a Wiltshire side to a retailer, the seller may at the written request of the retailer cut a Wiltshire side and sell on behalf of the retailer any fore-end, middle, or gammon obtained therefrom, provided that the seller shall keep a separate record of all such transactions.”
