CUSTOMS.

Additional Import Duties (No. 11) Order.

WHEREAS by the Additional Import Duties (No. 1) Order, 1932, made under Section 2 of the Isle of Man (Customs) (No. 2) Act, 1932, it was directed that as from the date of the making of that Order there should, on the removal or importation into this Isle of goods of such classes and descriptions as were specified in a certain Treasury Order (therein referred to as "the principal Treasury Order") as amended by certain other Treasury Orders, be payable, subject to and in accordance with the principal Treasury Order as so amended, such additional duties of Customs as were specified therein.

AND WHEREAS the Additional Import Duties (No. 1) Order has been amended by various subsequent Orders.

AND WHEREAS the principal Treasury Order has now been further amended by Treasury Orders No. 9 of the 6th May, 1933, No. 10 of the 30th May, 1933, No. 11 of the 12th June, 1933, No. 12 of the 16th June, 1933, and No. 13 of the 23rd June, 1933.

NOW, THEREFORE, I the said Lieutenant-Governor, by virtue of the powers conferred on me by subsection (5) of the said section two and of all other powers enabling me in that behalf, hereby make the following Order:—

1. As from the date of the making of this Order, references in paragraph 1 of the Additional Import Duties (No. 1) Order, 1932, shall be construed as references to the principal Treasury Order as further amended by the said Treasury Orders No. 9 of the 6th May, 1933, No. 10 of the 30th May, 1933, No. 11 of the 12th June, 1933, No. 12 of the 16th June, 1933, and No. 13 of the 23rd June, 1933.
2. This Order may be cited as the Additional Import Duties (No. 11) Order.
