### CUSTOMS

THE IMPORT DUTIES (EXEMPTIONS) (No. 5) (ISLE OF MAN) ORDER, 1940.

(CINEMATOGRAPH FILMS)  
(SOUND TRACK NEGATIVES)

WHEREAS the Treasury has by Order (No. 4) dated the 5th day of June, 1940, made under section 7 of the Finance Act, 1932, section 10 of the Finance Act, 1934, and section 1 of the Import Duties (Emergency Provisions) Act, 1939, ordered that the First Schedule to the Import Duties Act, 1932, as amended by the Import Duties (Exemptions Consolidation) Order, 1935, and by subsequent Orders, shall be further amended.

NOW, THEREFORE, I, the said Lieutenant Governor, by virtue of the powers conferred on me by section 1 of the Isle of Man (Customs) (No. 2) Act, 1932, and section 5 of the Isle of Man (Customs) Act, 1934, and of all powers enabling me in that behalf, make the following Order :—

1. The First Schedule to the Isle of Man (Customs) Act, 1932, as amended by the Import Duties (Exemptions Consolidation) (Isle of Man) Order, 1936, and by subsequent Orders, shall be further amended by deleting paragraph (1) of Group XIV and by re-numbering paragraphs (2) to (5) of that Group as paragraphs (1) to (4) respectively, and the Second Annex to the Import Duties (Exemptions Consolidation) (Isle of Man) Order, 1936, as amended by subsequent Orders shall be further amended in like manner.
2. (1) This Order may be cited as the Import Duties (Exemptions) (No. 5) (Isle of Man) Order, 1940.  
(2) This Order shall come into operation on the 21st day of June, 1940.
