**The Bananas Order, 1950.**

---

His Excellency the Lieutenant Governor has made the above-styled Order, a copy of which is appended.

This Order which is consequential upon the revocation of the Fresh Fruit and Vegetables (Record of Dealings) Order, 1949, which takes effect simultaneously, amends the Bananas Order, 1948, by providing for the keeping of records of sales of bananas otherwise than by retail.

The Order comes into force on the 15th January, 1950.

Copies of the Order may be seen at Government Office, or may be seen at any Police Station on application to the Officer in Charge, at the Douglas Public Library, the Douglas Town Hall and the Offices of all the Town and Village Commissioners.

Failure to comply with the terms of the Order renders a person liable to the penalties imposed by the Defence Regulations.

**THE BANANAS ORDER, 1950.**

---

I, the said Lieutenant Governor, in exercise of the powers conferred upon me by Regulations 55, 55AA and 98 of the Defence (General) Regulations (Isle of Man), 1939, as having effect by virtue of the Supplies and Services (Transitional Powers) (Isle of Man) Order in Council, 1946, as extended by the Supplies and Services (Extended Purposes) (Isle of Man) Order in Council, 1948, DO hereby make the following Order:—

1. The Bananas Order, 1948, shall be amended by inserting after Article 9 thereof the following Article:—

“9A. Every person who sells bananas otherwise than by retail shall keep or cause to be kept an accurate record of all purchases and sales by him of bananas otherwise than by retail; and such record shall include the following particulars of each purchase and sale—

- (i) the date of the purchase or sale;
- (ii) the name and address of the person from whom he purchased or to whom he sold the bananas;
- (iii) the net weight of bananas purchased or sold; and
- (iv) particulars of each and every addition to the maximum price charged in accordance with the provisions of this Order, including any charge by way of deposit for a returnable package or container and particulars of the repayment or crediting of any charge by way of deposit.”

2. This Order may be cited as the Bananas Order, 1950; and shall come into operation on the 15th day of January, 1950.
