THE CITRUS FRUIT ORDER, 1950.

His Excellency the Lieutenant Governor has made the above styled Order, a copy of which is appended.

This Order, which is consequential upon the revocation of the Fresh Fruit and Vegetables (Record of Dealings) Order, 1949, which takes effect simultaneously, further amends the Citrus Fruits (Maximum Prices) Order, 1944, by providing for the keeping of records of sales of oranges and grapefruit otherwise than by retail.

The Order comes into force on the 15th January, 1950.

Copies of the Order may be obtained at Government Office, or may be seen at any Police Station on application to the Officer in Charge, at the Douglas Public Library, the Douglas Town Hall and the Offices of all the Town and Village Commissioners.

Failure to comply with the terms of the Order renders a person liable to the penalties imposed by the Defence Regulations.

SUPPLIES AND SERVICES.

THE CITRUS FRUIT ORDER, 1950.

I, the said Lieutenant Governor, in exercise of the powers conferred upon me by Regulations 55, 55AA and 98 of the Defence (General Regulations (Isle of Man), 1939, as having effect by virtue of the Supplies and Services (Transitional Powers) (Isle of Man) Order in Council, 1946, as extended by the Supplies and Services (Extended Purposes) (Isle of Man) Order in Council, 1948, DO hereby make the following Order :—

1. The Citrus Fruit (Maximum Prices) Order, 1944, as amended, shall be further amended by inserting after Article 4b thereof the following article—

[P.T.O.]

" 4c. Every person who sells citrus fruit otherwise than by retail shall keep or cause to be kept an accurate record of all purchases and sales by him of citrus fruit otherwise than by retail; and such record shall include the following particulars of each purchase and sale—

- (i) the date of the purchase or sale;
- (ii) the name and address of the person from whom he purchased or to whom he sold the the citrus fruit;
- (iii) the net weight of citrus fruit purchased or sold, or if purchased or sold in specified packages, the number and description of such packages; and
- (iv) particulars of each and every addition to the maximum price charged in accordance with the provisions of this Order, including any charge by way of deposit for a returnable package or container and particulars of the repayment or crediting of any such charge by way of deposit."

2. This Order may be cited as the Citrus Fruit Order, 1950, and shall come into operation on the 15th day of January, 1950.
