THE FOOD (REGULATION OF IMPORTATION) (NO. 2) ORDER, 1950

In the new Schedule all items which were subject to the Points Rationing Orders have been removed.

THE FOOD (REGULATION OF IMPORTATION)
(NO 2) ORDER, 1950

I, the said Lieutenant Governor, in exercise of the powers conferred upon me by Regulations 55, 55AA and 98 of the Defence (General) Regulations (Isle of Man) 1939, as having effect by virtue of the Supplies and Services (Transitional Powers) (Isle of Man) Order in Council, 1946, as extended by the Supplies and Services (Extended Purposes) (Isle of Man) Order in Council, 1948, DO hereby make the following Order:—

1. The Food (Regulation of Importation) Order, 1948, as amended, shall be further amended by substituting for the Schedule thereto the Schedule to this Order.
2. The Food (Regulation of Importation) Order, 1950, dated 24th April, 1950, is hereby revoked but without prejudice to any proceedings in respect of any contravention thereof.
3. This Order may be cited as The Food (Regulation of Importation) (No. 2) Order, 1950, and shall come into force on the 22nd day of May, 1950.

THE SCHEDULE

MILK POWDER (which means milk which has been concentrated to the form of powder or solid by the removal of water).

TEA.

BUTTER.

MARGARINE.

COOKING FATS (which includes any fat or mixture of oils and fats fit for human food or for use in the manufacture, preparation or treatment of human food, having a melting point which when determined by the method specified in the Fourth Schedule to the Oils and Fats Order, 1949, is not less than 30 degrees centigrade, and for the purpose of this Order shall include lard).

OILS, FATS and MIXTURES specified in Parts I and III of the First Schedule to the Oils and Fats Order, 1949.

BACON.

HAM.

SUGAR.

CHEESE (other than Parmesan, Imported Blue Vein, Stilton, Blue Cheshire, Pont l'Eveque, Carr de l'Est, Camembert, Brie, Swiss Emmenthal, Petit Gruyere, Fromage Demisel, Saint Paulin, Scandinavian Primula Cheeses, Italian full cream soft cheese, soft cheese, curd cheese, lactic cheese, and cheese made from milk other than cow's milk).

EGGS.

ICE CREAM (including water ices and any commodity whether frozen or chilled and under whatever description it is sold which is substantially similar to or may be used as a substitute for ice cream or calculated to lead to the belief that the commodity sold is ice cream).

FLOUR.

LIVE POULTRY.

For the purposes of this Schedule "imported" means imported into the United Kingdom and subsequently imported into the Isle of Man, or imported directly into the Isle of Man.
