CONDITIONS GOVERNING THE EMPLOYMENT OF MEMBERS OF
ISLE OF MAN CONSTABULARY AT RACE MEETINGS AND
PLACES OF SPORT OR ENTERTAINMENT AND PRIVATE
FUNCTIONS.

Owing to recent changes in the pay and National Insurance contributions of the Police, His Excellency the Lieutenant Governor has found it necessary to order that in future :-

1. (a) The functions of the police when lent for duty on private property, at race meetings, places of sport or entertainment, or for private functions, shall be restricted to those duties which would be discharged by the police in the ordinary course;

(b) Members of the Isle of Man Constabulary lent for duty at race meetings, places of sport or entertainment, or at private functions, shall discharge such duties as part of their daily duty, or when occasion demands, as overtime duty; and

(c) The following terms and conditions for the employment of police at race meetings, places of sport or entertainment, or at private functions shall be strictly observed.

2. (a) Any authority or private individual desirous of employing members of the Isle of Man Constabulary for extra police duty, in terms of 1 above, shall submit in writing an application to the Chief Constable indicating the number of men desired and the date and hour on which the services of such men are required and the period of their employment;

(b) The Chief Constable will grant or refuse the application according to the circumstances and the availability of police for such purpose;

(c) The Chief Constable will arrange to collect from the responsible authority or person, whenever police are lent, the fees due at the rates specified in this Circular. The Chief Constable will furnish to the Government Treasurer full particulars of the number of men lent on each occasion and the period of their employment, and will transmit to the Government Treasurer a quarterly return accompanied by the fees received;

(d) Overtime, if any, in respect of duties carried out by members of the Isle of Man Constabulary when lent for private duty shall be dealt with in the usual manner;

(e) No member of the Isle of Man Constabulary shall be employed in any premises licensed for the sale of intoxicating liquor or for public music and dancing; and

(f) The following charges for members of the Isle of Man Constabulary lent to authorities or private individuals will be operative as from the date hereof until amended.

3. A copy of this Circular shall be handed to all authorities and private individuals to whom the police are lent.

4. Government Circular No. 24/65 is hereby cancelled.
