BETTING ACT 1970

THE BETTING (LICENSING) REGULATIONS, 1970

In exercise of the powers conferred on me by subsection (1) of section 12 of, and paragraphs 5, 10, 22, 25 and 30 of the First Schedule to, the Betting Act, 1970, I, the said Lieutenant Governor, DO HEREBY make the following Regulations:-

Application for grant of permits and licences.

1. An application made in accordance with paragraph 5 of the First Schedule to the Act for the grant of a bookmaker's permit, or betting office licence, shall be made in writing in the form numbered 1 or 2 as the case may be, in the Schedule to these Regulations and shall contain such particulars and, if the application is for a permit, give such references as are required thereby.

Application for renewal of permits and licences.

2. An application made in accordance with paragraph 10 of the First Schedule to the Act for the renewal of a bookmaker's permit, or betting office licence, shall be made in writing in the form numbered 3 or 4, as the case may be, in the Schedule to these Regulations, and shall contain such particulars as are required thereby.

Form of permits and licences

3. A bookmaker's permit, or a betting office licence shall be granted in the form numbered 5 and renewed in the form numbered 6 in the Schedule to these Regulations.

Provided that such a permit or licence, sealed with an official seal impressed under the authority of the Board, may be signed by the Secretary of the Board instead of by a member thereof.

Application for cancellation of bookmaker's permit.

4. An application made in accordance with paragraph 22 of the First Schedule to the Act for the forfeiture and cancellation of a bookmaker's permit shall be made in writing in the form numbered 7 in the Schedule to these Regulations.

Register of permits and licences.

5. The Secretary of the Board shall, in accordance with paragraph 30 of the First Schedule to the Act, keep registers of bookmaker's permits, and betting office licences granted or renewed by the Board in, and containing the particulars required by, the forms numbered 8 and 9 respectively in the Schedule to these Regulations and there shall be included in the appropriate register -

- (a) in the case of a bookmaker's permit which is cancelled under section six of the Act, or of a bookmaker's permit which is cancelled under paragraph 23 of the First Schedule to the Act, particulars of the cancellation;
- (b) in the case of a betting office licence which, by virtue of paragraph 28 of the First Schedule to the Act, ceases to be in force, particulars of the circumstances in which it ceases to be in force; and
- (c) in the case of a bookmaker's permit, or betting office licence which, by virtue of paragraph 29 of the First Schedule to the Act, is deemed to be held by the personal representatives of the person to whom it was granted, particulars of the period for which it is deemed to be so held and any extension thereof.

Fee for inspection of registers.

6. A register of bookmaker's permits, or of betting office licences shall, in accordance with paragraph 30 of the First Schedule to the Act, be open during reasonable hours for inspection on payment by persons other than constables or officers of a fee of five shillings.

Interpretation and application

7. (1) In these Regulations "Board" means the Isle of Man Gaming Board of Control constituted in terms of section seven of the Gaming Betting and Lotteries ^(Casino) Act 1962.

(2) In these Regulations any reference to the Act is a reference to the Betting Act, 1970.

(3) In these Regulations any reference to a form in the Schedule to these Regulations shall include a reference to a form to the like effect with such variations as the circumstances may require.

(4) The Interpretation Acts 1949 and 1968 shall apply for the interpretation of these Regulations as they apply for the interpretation of an Act of Tynwald.

Citation and commencement.

8. These Regulations may be cited as the Betting (Licensing) Regulations, 1970, and shall come into operation on the date hereof.

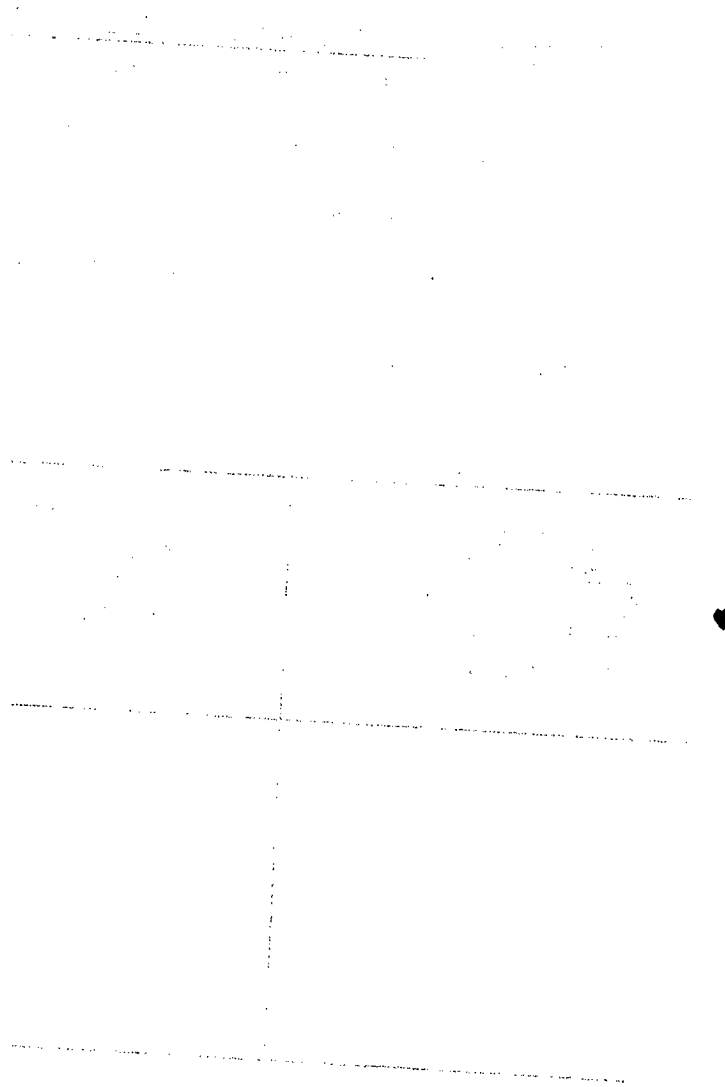
