REPRESENTATION OF THE PEOPLE (TABLE OF FEES)
(AMENDMENT) ORDER, 1970.

I, the said Lieutenant Governor by virtue of
the powers conferred on me by section 75 of the
Representation of the People Act, 1951, DO hereby
make the following Order:-

1. The Table of Fees set forth in the Sixth
Schedule to the Representation of the People Act,
1951, as amended by the Representation of the
People (Table of Fees) (No.1 Amendment) Order,
1956, the Representation of the People (Table of
Fees) (No.2 Amendment) Order, 1956, the Representation
of the People (Table of Fees) (Amendment) Order, 1964
and the Representation of the People (Table of
Fees) (Amendment) Order 1965, shall be further
amended as hereinafter prescribed.

2. For paragraph 8 of the said Table of Fees
the following paragraph shall be substituted:-

"8. A registration officer for gathering
information necessary to enable him to
compile the list of electors in a polling
district where the number of electors -

(a) does not exceed 250, for every
elector 1/-d with a minimum fee of... ..£ 3.0.0.

(b) exceeds 250, but does not
exceed 1,000 for every 100 electors
or portion of a 100, at the rate
per 100 of£ 4.3.0.

(c) exceeds 1,000 but does not
exceed 2,000 for every 100 electors
or portion of a 100, at the rate
per 100 of£3. 3.0.

(d) exceeds 2,000 for every
100 electors up to 5,000 at the
rate per 100 of £ 2.17.0.

(e) for every 100 electors or
portion of a 100 beyond 5,000
at the rate per 100 of £ 2.10.0.

Provided that the expenditure
allowable under any item of the
above scale shall not be less than
the maximum allowable under the
preceding item."

3. This Order shall take effect when approved
by resolution of Tynwald and may be cited as
the Representation of the People (Table of
Fees)(Amendment) Order,1970 and this Order
and the Representation of the People (Table of
Fees)(Amendment) Orders 1956 to 1965 may be
together cited as the Representation of the
People (Table of Fees)(Amendment) Orders,1956 -
1970.
