**THE ISLE OF MAN BOARD OF  
SOCIAL SECURITY ACT 1970  
(COMMENCEMENT) ORDER 1970**

---

WHEREAS paragraph (b) of subsection (1) of section 39 of the Isle of Man Board of Social Security Act 1970 (hereinafter referred to as "the Act") provides that the Governor may, by order, appoint the day on which the provisions of the Act other than sections 38 and 39, shall take effect.

AND WHEREAS subsection (2) of section 39 of the Act provides that the Governor may appoint different days for different provisions of the Act.

NOW THEREFORE I, the said Lieutenant Governor, in exercise of the powers conferred on me by the Act and of all other powers enabling me in that behalf, DO hereby make the following Order—

PRICE: 1/- (5p)

**1.** The day appointed for the taking effect of any provision of the Act specified in column 1 of the Schedule to this Order, so far as that provision relates to any subject matter specified in column 2 of that Schedule, shall be the date specified in column 3 of that Schedule in relation to that subject matter.

**2.** This Order may be cited as the Isle of Man Board of Social Security Act 1970 (Commencement) Order 1970.
