PAYMENT OF MEMBERS' EXPENSES ACT, 1962

PAYMENT OF MEMBERS' EXPENSES ACT, 1962, ORDER, 1970

WHEREAS it is provided by Section 2 (1) of the Payment of Members' Expenses Act, 1962, that the Governor may by Order with the approval of Tynwald declare that the provisions of Section 7 or of Section 8 or of both such sections of the Payment of Members' Expenses Act, 1957 (hereinafter called "the principal Act") (which sections respectively provide for the payment of remuneration and travelling expenses to every person who is a member of a Board of Tynwald or other body therein specified and who is not a member of Tynwald) shall apply to every person who is a member of any Government or other body which is named in the Order and who is not a Member of Tynwald.

NOW, therefore, I, the said Lieutenant Governor, by virtue and in exercise of the powers conferred on me by the said Section 2 (1) of the Payment of Members' Expenses Act, 1962 DO hereby declare and direct that -

1. The provisions of Section 7 of the principal Act shall apply to the Government bodies named in Schedule I to this Order with effect from 12th May, 1970.
2. The provisions of Section 8 of the principal Act shall apply to the Government bodies named in Schedule II to this Order with effect from 12th May, 1970.
3. The Interpretation Act 1970 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Tynwald.
