THE ISLE OF MAN CROWN GREEN BOWLING FESTIVAL (NO 2) ORDER 1990

This Order, a copy of which is attached was made by the Isle of Man Gaming Control Commissioners on 9th April 1990, and submitted to Tynwald for approval at the May 1990 sitting of the Court.

The Order modifies the Gaming, Betting and Lotteries Act 1988 to allow bets to be taken by approved bookmakers at the approved bowling festival venues which would otherwise be unlawful.

THE ISLE OF MAN GAMING CONTROL COMMISSIONERS

THE CROWN GREEN BOWLING FESTIVAL (NO 2) ORDER 1990

In exercise of the powers conferred on the Isle of Man Gaming Control Commissioners by Section 25 of the Gaming, Betting and Lotteries Act 1988 (a), and of all other enabling powers, the following Order is hereby made:

Citation and Operation

1. (1) This Order may be cited as the Isle of Man Crown Green Bowling Festival (No 2) Order 1990.

(2) Subject to Section 47(2) of the Gaming, Betting and Lotteries Act 1988, this Order shall come into operation on the 3rd September 1990 and shall cease to have effect on 8th September 1990.


Modification of Gaming, Betting & Lotteries Act 1988

2. During the period is in operation the Gaming, Betting and Lotteries Act 1988 shall have effect subject to the modifications specified in the Schedule.

SCHEDULE

MODIFICATIONS OF THE GAMING, BETTING AND LOTTERIES ACT 1988

Bookmakers Permits

In Section 14, after subsection (2) insert -

"(2A) Subsections (1) and (2) shall not apply to the receiving or negotiating of bets at an approved bowling green by a person who is -

(a) the holder of a permit under Section 2 of the Betting, Gaming and Lotteries Act 1963 (c) (an Act of Parliament), and

(b) approved in writing by the Commissioners for the purpose of this subsection."

Betting Office Licences

In Section 15, after subsection (2) insert -

"(2A) Subsections (1) and (2) apply to the stall or stand at an approved bowling green of -

(a) the holder of a Bookmakers' Permit, or

(b) a person referred to in Section 14(2A),

as they apply to a licensed betting office.

Interpretation

In Section 48, after the definition of "approved accounting body" insert -

"approved bowling green" means any crown bowling green at the following locations:

1. Finch Hill Bowling Green, Douglas
2. Nobles Park, Douglas
3. Onchan Park, Douglas
4. Villa Marina, Douglas
