Road Traffic Regulation Act 1985

BOROUGH OF DOUGLAS (TRAFFIC REGULATION) (AMENDMENT) ORDER 1993

In exercise of the powers conferred on the Department of Highways, Ports and Properties by Section 1 of the Road Traffic Regulation Act 1985 (a), and of all other enabling powers, the following Order is hereby made: -

Citation and Commencement

This Order may be cited as the Borough of Douglas (Traffic Regulation) (Amendment) Order 1993 and shall come into operation on the 2nd February 1993.

Amendment to Principal Order

- The Traffic Regulations Consolidation Order 1981 (No (b) made by the Douglas Corporation shall be further amended by insertion of the following:-
- (a) After entry No 12 (Circular Road)

"12A Circular Road

Southside from a point Waiting restricted approx. 20 metres west to two hours in any of its junction with Bucks Road westwards to a point approx. 10 metres east of its junction with the lane at the rear of Goldie Terrace excepting the area marked out as a bus stop which shall be no waiting at any time.

four between 8.00am and 6.00pm Monday to Saturday.

Southside from its junction with Bucks Road westwards for a distance of approx. 20 metres.

No waiting at any time.

Southwards from its junction with the lane at the rear of Goldie Terrace eastwards for a distance of approx. 10 metres.

No waiting at any time".

(b) After entry No 36 (Rosemount)

"36A Springfield Road Eastside from its No waiting 8.00am junction with Heather to 6.00pm"

Explanatory Note (This note is not a part of the Order)

The effect of this Order is to:-

- 1 Prohibit vehicles from waiting in excess of two hours in any four between 8.00am and 6.00pm Monday to Saturday inclusive, on the south side of Circular Road from a point approx. 20 metres west of its junction with Bucks Road westwards to a point approx. 10 metres east of its junction with the lane at the rear of Goldie Terrace, with the exception of the area marked out as a bus stop which shall be no waiting at any time.
- 2 Prohibit vehicles from waiting at any time on the south side of Circular Road westwards from its junction with Bucks Road for a distance of approx. 20 metres westwards.
- 3 Prohibit vehicles from waiting at any time on the south side of Circular Road from its junction with the lane at the rear of Goldie Terrace for a distance of approx. 10 metres eastwards.
- 4 Prohibit vehicles from waiting between 8.00am and 6.00pm on the east side of Springfield Road to its junction with Heather Crescent northwards to its easternmost junction with Springfield Avenue.
