(AMENDMENT) REGULATIONS 1993

COMING INTO OPERATION 5 APRIL 1993

In exercise of the powers conferred on the Isle of Man Post Office Authority by Section 6 of the Isle of Man Post Office Authority (Postal Services, etc.) Act 1973 (a), and of all other enabling powers, the following Regulations are hereby made: -

Citation and commencement

1. These Regulations may be cited as the Isle of Man Post Office Authority (Inland Post) (Amendment) Regulations 1993 and shall come into operation on the 5th April 1993.

Amendments

2. The Isle of Man Post Office Authority (Inland Post) Regulations 1977 (b) shall be amended in accordance with Schedule 1.

Revocations

3. The public document mentioned in Schedule 2 is revoked to the extent specified in the third column of that Schedule.

EXPLANATORY NOTE

(This Note is not part of the Regulations)

1. These Regulations amend the Isle of Man Post Office Authority (Inland Post) Regulations 1977, by -
 - (a) increasing the charges for posting local letters;
 - (b) increasing the charge (first weight step only) for posting letters to the United Kingdom, Channel Islands and Irish Republic;
 - (c) increasing the charge (first weight step only) for posting registered newspapers;
2. These changes take effect from 5th April 1993.
