



ROAD TRAFFIC REGULATION ACT 1985

**A23 SCHOOL ROAD (BRADDAN)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 1997**

Coming into Operation: 17th February 1997

In exercise of the powers conferred on the Department of Transport by Section 3 of the Road Traffic Regulation Act 1985 (a), and of all other enabling powers, and after having complied with the procedure set out in Schedule 1 to the Act as required by Section 3 (1) and after having been satisfied that Section 1(8) of the act does not apply, the following Order is hereby made :-

Citation and commencement

1. This Order may be cited as the A23 School Road (Braddan) (Temporary Prohibition of Through Traffic) Order 1997 and shall come into operation at 9.30 a.m. on 17th February 1997.

Closure of road to vehicular traffic

2. Subject to Article 3, no person shall except upon the direction or with the permission of a constable in uniform, cause any vehicle to proceed in that section of the A23 School Road, Braddan from its junction with the A1 Douglas to Peel Road at Braddan Bridge to its junction with the A21 Ballafletcher Road.

Exemptions

3. Article 2 does not apply to a vehicle requiring access to premises or land adjacent to the road specified in Article 2 or to :-

- (1) a vehicle engaged in any of the following operations:
 - (a) works in land or premises adjacent to the road specified in Article 2;
 - (b) works in the road specified in Article 2 authorised by statutory provisions; or
 - (c) in the service of a local authority or the Department of Transport in pursuance of any statutory functions in the road or in adjacent land or premises

if it cannot conveniently be used for such purposes on any other road; or

(2) a vehicle being used in the course of duty by the police, fire brigade, ambulance service or coastguard; or

(3) a vehicle for which the driver holds a permit issued by the Department of Transport for its use in the road, while the vehicle is being used at a time or for a purpose specified in the permit; to


(4) such vehicular traffic as may be authorised by the Department

Duration

4. The Order shall continue in force until 4.00 p.m on 17th February 1997 and then from 9.30 a.m. to 4.00 p.m. on 18th February 1997 or until the tree maintenance work is completed whichever is the earlier.

EXPLANATORY NOTE

(This note is not a part of the Order)

The effect of this Order is to prohibit vehicular traffic from proceeding in that section of the A23 Braddan School Road from its junction with the A1 Douglas To Peel road at Braddan Bridge to its junction with the A21 Ballafletcher Road whilst tree maintenance work is being undertaken.

An alternative route will be via Ballafletcher Road, Ballanard Road, Bray Hill and Quarterbridge Road.
