



ROAD TRAFFIC REGULATION ACT 1985

**BOROUGH OF DOUGLAS (VARIOUS ROADS)
(RESERVED PARKING PLACES)(AMENDMENT)(NO 1) ORDER 1997**

Coming into Operation : 16th April 1997

In exercise of the powers conferred on the Department of Transport by Section 14 of the Road Traffic Regulation Act 1985 (a), and of all other powers, and after having complied with the procedure set out in Schedule 2 to the Act as required by Section 4A, the following Order is hereby made :-

Citation and commencement

1. This Order may be cited as the Borough of Douglas (Various Roads)(Reserved Parking Places)(Amendment) (No 1) Order 1997 and shall come into operation on the 16th April 1997

Amendment of principal Order

2. The Borough of Douglas (Various Roads) (Reserved Parking Places) (Consolidation) Order 1995 (Schedule 1) (b) shall be amended in accordance with the following provisions of this Order.

3. After entry No 7 Berkeley Street insert the following entry :-

"(c) Northside fronting the property
numbered 16"

4. After entry No 12A Central Promenade insert the following entry :-

"12B Castle Drive

(a) Southside fronting the property
numbered 4"

5. After entry No 19 Falcon Street insert the following entry :-

"(b) Southside fronting the property
numbered 31"

(b) SD 37/95

6. After entry No 26 Hope Street insert the following entry :-

"26A Hutchinson Square

(a) Westside fronting the property
numbered 7 (Addison House Residential Home)"

7. After entry No 42A Spring Valley Road insert the following entry :-

"42B St Catherines Drive

(a) Eastside fronting the property
numbered 13"

8. After entry No 43 Switzerland Road (Cliff Flats) insert the following entry:-

"(b) Westside fronting the property
numbered 1 Switzerland Terrace."



EXPLANATORY NOTE

(This note is not a part of the Order)

The effect of this Order is to provide reserved parking places on sections of Berkeley Street, Castle Drive, Falcon Street, Hutchinson Square, St Catherines Drive and Switzerland Road in the Borough of Douglas for a vehicle displaying a reserved parking permit issued by the Department and to revoke and remove reserved parking places on sections of Brisbane Street, Castle Mona Avenue, Christian Road, Derby Square and Hillside Terrace in the Borough of Douglas.
