



ROAD TRAFFIC REGULATION ACT 1985

**BOROUGH OF DOUGLAS (CUMBERLAND TERRACE)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 1997**

Coming into Operation: 18th April 1997

In exercise of the powers conferred on the Department of Transport by Section 3 of the Road Traffic Regulation Act 1985 (a), and of all other enabling powers, and after having complied with the procedure set out in Schedule 1 to the Act as required by Section 3(1) and after having been satisfied that Section 1(8) of the Act does not apply the following Order is hereby made :-

Citation and commencement

1. This Order may be cited as Borough of Douglas (Cumberland Terrace) (Temporary Prohibition of Through Traffic) Order 1997 and shall come into operation at 6.00 p.m. on 18th April 1997.

Closure of road to vehicular traffic

2. Subject to Article 3, no person shall except upon the direction or with the permission of a constable in uniform, cause any vehicle to proceed in that section of Cumberland Terrace, Douglas from its junction with St Georges Street to its junction with Westmoreland Road.

Exemptions

3. Article 2 does not apply to persons or vehicles requiring access to premises or land adjacent to the road specified in Article 2 or to :-

- (1) persons or vehicles engaged in any of the following operations :-
 - (a) works in land or premises adjacent to the road specified in Article 2;
 - (b) works in the road specified in Article 2 authorised by statutory provisions; or
 - (c) in the service of a local authority or the Department of Transport in pursuance of any statutory functions in the road or in adjacent land or premises, if it cannot conveniently be used for such purposes on any other roads; or
- (2) a vehicle being used in the course of duty by the police, fire brigade, ambulance service or coastguard service; or

- (3) a vehicle for which the driver holds a permit issued by the Department of Transport for its use in the road, at a time or for a purpose specified in the permit; or
- (4) such vehicular traffic as may be authorised by the Department.

Duration

4. The Order shall continue in force :-

From	To
6.00 p.m. on 18.4.97	7.00 a.m. on 21.4.97
6.00 p.m. on 25.4.97	7.00 a.m. on 28.4.97
6.00 p.m. on 9.5.97	7.00 a.m. on 12.5.97

or until the drainage work is completed, whichever is the earlier.

EXPLANATORY NOTE

The effect of this Order is to prohibit vehicular traffic from proceeding in that section of Cumberland Terrace, Douglas from its junction with St Georges Street to its junction with Westmoreland Road whilst drainage work is being undertaken.
