



## HIGHWAYS ACT 1986

### **B30 BALLAMODDA/ST MARKS ROAD (MALEW) FILMING ORDER 1998**

*Coming into Operation : 22<sup>nd</sup> January 1998*

In exercise of powers conferred on the Department of Transport by Section 38 of the Highways Act 1986 (a), and of all other enabling powers, the following Order is hereby made :-

#### **Citation and commencement**

1. This Order may be cited as the B30 Ballamodda/St Marks Road (Malew) Filming Order 1998 and shall come into operation on Thursday 22<sup>nd</sup> January 1998.

#### **Interpretation**

2. In this Order :-

“the Department” means the Department of Transport;

“the promoter” means the producers of Dreaming of Joseph Lees;

“filming” means filming on the Ballamodda/St Marks Road in St Marks Village;

“filming periods” means on 22<sup>nd</sup>, 24<sup>th</sup>, 25<sup>th</sup>, 26<sup>th</sup>, 27<sup>th</sup>, 28<sup>th</sup> and 29<sup>th</sup> January 1998 from the hour of 7.00am until the filming is officially notified as completed in accordance with Article 4 or until not later than the hour of 8.00 pm whichever shall be earlier.

“Scheduled road” means the road set out and described in the Schedule.

#### **Closure of road and temporary suspension of regulation traffic**

3. On the 22<sup>nd</sup>, 24<sup>th</sup>, 25<sup>th</sup>, 26<sup>th</sup>, 27<sup>th</sup>, 28<sup>th</sup> and 29<sup>th</sup> January 1998 during the filming periods the Scheduled road shall be closed to, and the right of vehicular traffic to proceed therefore suspended for, all vehicular traffic other than such traffic as may be authorised by the promoter or by the Chief Constable.

**Duty of the police to notify completion of filming**

4. It shall be the duty of the senior police officer present to make such provision as seems most expedient for giving official notification to the public of the conclusion of the filming and of the opening of the Scheduled road to traffic.

**Erection of barriers and diversion signs**

5. During the filming periods the promoter will cause barriers and diversion signs to be erected and maintained at or near to the junction of the Scheduled road with those roads leading into the Scheduled road. Such barriers and diversion signs must be dismantled and removed immediately after the conclusion of the filming periods.

**Notice of the making of the Order**

6. Public notice of this Order shall be given by advertisement in two Isle of Man newspapers.

SCHEDULE

The B30 Ballamodda/St Marks Road in St Marks Village from its junction with the A26 Ballasalla to Glen Vine Road to its junction with the unnamed link road between the Ballamodda/ St Marks Road and the Ballasalla to Glen Vine Road in the Parish of Malew.

Access will be maintained to all properties situated thereon.
