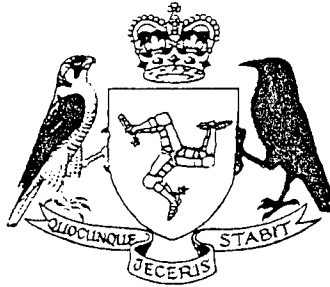

ROAD TRAFFIC REGULATION ACT 1985

**BOROUGH OF DOUGLAS (KING EDWARD ROAD)  
(TEMPORARY SUSPENSION OF PARKING PLACES) ORDER 1998**

*Coming into Operation : 1<sup>st</sup>/2<sup>nd</sup> February 1998*

In exercise of the powers conferred on the Department of Transport by Section 3 of the Road Traffic Regulation Act 1985 (a), and of all other enabling powers, and after having complied with the procedure set out in Schedule 1 to the Act as required by Section 3(1), the following Order is hereby made :-

**Citation and commencement**

1. This Order may be cited as the Borough of Douglas (King Edward Road) (Temporary Suspension of Parking Places) Order 1998 and shall come into operation at midnight on Sunday 1<sup>st</sup>/Monday 2<sup>nd</sup> February 1998.

**Temporary suspension of parking**

2. No person shall cause any vehicle other than those being used for filming purposes to be parked on the seaward side of King Edward Road, Douglas.

**Duration**

3. This Order shall continue in force until 5.00 p.m. on Monday 2<sup>nd</sup> February 1998 or until the filming work is completed whichever is the earlier.

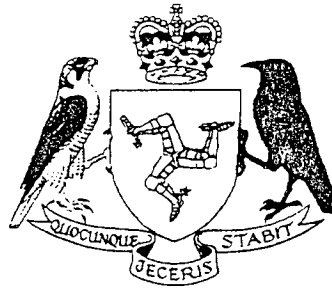
