

ROAD TRAFFIC REGULATION ACT 1985

**A22 STRANG ROAD (BRADDAN)  
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 1998**

*Coming into Operation: 22<sup>nd</sup> March 1998*

In exercise of the powers conferred on the Department of Transport by Section 3 of the Road Traffic Regulation Act 1985 (a), and of all other enabling powers, and after having complied with the procedure set out in Schedule 1 to the Act as required by Section 3(1) and after having been satisfied that Section 1(8) of the Act does not apply the following Order is hereby made:-

**Citation and commencement**

1. This Order may be cited as the A22 Strang Road (Braddan) (Temporary Prohibition of Through Traffic) Order 1998 and shall come into operation at 8.00a.m. on Sunday 22<sup>nd</sup> March 1998.

**Closure of road to vehicular traffic**

2. Subject to Article 3, no person shall except upon the direction or with the permission of a constable in uniform, cause any vehicle to proceed in that section of A22 Strang Road, Braddan at its junction with the A21 Peel Road at Union Mills.

**Exemptions**

3. Article 2 does not apply to a vehicle requiring access to premises or land adjacent to the road specified in Article 2 or to -

(1) a vehicle engaged in any of the following operations :

(a) works in land or premises adjacent to the road specified in Article 2; or

(b) works in the road specified in Article 2 authorised by statutory provisions;  
or

(c) in the service of a local authority or the Department of Transport in pursuance of any statutory functions in the road or in adjacent land or premises.

(2) a vehicle being used in the course of duty for the police, fire brigade, ambulance or coastguard service; or

(3) a vehicle for which the driver holds a permit issued by the Department of Transport for its use in the road, while the vehicle is being used at a time or for a purpose specified in the permit; or

(4) such vehicular traffic as may be authorised by the Department.


### Duration

4. The Order shall continue in force until 6.00 p.m. on Sunday 22nd March 1998, or until the road resurfacing is completed, whichever is the earlier.

### Provision of postponement of road resurfacing

5. In the event of adverse weather conditions on the 22<sup>nd</sup> March 1998 the road resurfacing work may be postponed to 8.00 a.m. on Sunday 29<sup>th</sup> March 1998 and in such event this Order shall have effect where the context so admits as if that day were substituted for the 22<sup>nd</sup> March 1998.

### EXPLANATORY NOTE

*(This note is not a part of the Order)*

The effect of this Order is to prohibit vehicular traffic from proceeding on that section of the Strang Road, Braddan at its junction with A1 Peel Road at Union Mills whilst road resurfacing is being undertaken.

An alternative route will be via Peel Road over Union Mills Bridge.
