**THE ROADS IN VILLAGE DISTRICTS
(ABOLITION AND VARIATION OF SPEED LIMITS) (AMENDMENT) (NO 1) ORDER 2002**

Coming into Operation: 17th June 2002

In exercise of the powers conferred on the Department of Transport by Section 17 of the Road Traffic Regulation Act 1963 (a), and all other enabling powers, and after having complied with the procedure set out in Schedule to the Road Traffic Regulation Act 1985 (b), the following Order is hereby made:-

Citation and commencement

1. This Order may be cited as the Roads in Village Districts (Abolition and Variation of Speed Limits) (Amendment) (No 1) Order 2002 and shall come into operation on 17th June 2002.

Variation of speed limits

2. The Roads in Village Districts (Abolition and Variation of Speed Limits) Order 1974 shall be further amended by the addition in the Second Schedule after paragraph 5 (Village District of Onchan) of the following entry:-


