



ROAD TRAFFIC REGULATION ACT 1985

**RURAL ROADS (SPEED LIMITS) (AMENDMENT) (NO 1 ) ORDER 2002**

*Coming into Operation : - 17th June 2002*

In exercise of the powers conferred on the Department of Transport by Section 23 of the Road Traffic Regulation Act 1985 (a) and of all other enabling powers, and after having complied with the procedure set out in Schedule 2 to the Act as required by Section 4A, the following Order is hereby made:-

**Citation and commencement**

1. This Order may be cited as the Rural Roads (Speed Limits) (Amendment) (No 1 ) Order 2002 and shall come into operation on 17th June 2002.

**Amendment of principal Order**

2. The Rural Roads (Speed Limits) Order 1979 (b) shall be further amended so as to have effect in accordance with the following provisions of this Order.

**Imposition of speed limits**

3. In Schedule 2 (Limits of Speed) after paragraph 1 (m) (Parish of Andreas) insert the following entry:-

“(n) all the roads within the Ballalough  
Housing Estate 20”

4. In Schedule 2 (Limits of Speed) delete paragraph 4(d)(i) (Parish of Ballaugh) and insert the following entry:-

“(i) all roads within the Ballacrosha Housing  
Estate 20”

5. In Schedule 2 (Limits of Speed) after paragraph 4(e) (Parish of Ballaugh) insert the following entry:-

“(f) the entire length of Mountain View 20”

6. In Schedule 2 (Limits of Speed) delete paragraph 4(d)(iv) (Parish of Ballaugh) and insert the following entry:-

(a) 1985 c.20 (b) G.C No 185/79

Price: 50p

Price Code: A

“(iv) all the roads within the Ballaterson Fields Housing Estate 20”

7. In Schedule 2 (Limits of Speed) delete paragraph 5(m) (Parish of Braddan) and insert the following entry:-

“(m) all the roads within the Ballamillaghyn Housing Estate 20”

8. In Schedule 2 (Limits of Speed) after paragraph 5(v) (Parish of Braddan) insert the following entry:-

“(w) all the roads within the Clybane Housing Estate 20”

9. In Schedule 2 (Limits of Speed) after paragraph 8A(b) (Parish of Jurby) insert the following entry:-

“(c) all the roads within The Bretney Housing Estate (including Bretney Close) 20

(d) all the roads within The Threshold Housing Estate (including Snaefell View) 20”


10. In Schedule 2 (Limits of Speed) delete paragraph 17(g) (Parish of Rushen) and insert the following entry:-

“(g) all the roads within the Fairy Hill Housing Estate (including Qualtroughs Lane (Ballafesson Farm Road)) 20”

#### EXPLANATORY NOTE

*(This note is not part of the Order)*

The effect of this Order is to impose a 20 mph speed limit on all the roads within the following housing estates:-

1. Ballalough in the Parish of Andreas.

2. Ballacrosha )  
Ballaterson Fields ) in the Parish of Ballaugh.  
The entire length of Mountain View )
3. Ballamillaghyn ) in the Parish of Braddan.  
Clybane )
4. The Bretney (including Bretney Close) and The Threshold (including Snaefell View) in the Parish of Jurby.
5. Fairy Hill in the Parish of Rushen (including Qualtroughs Lane (Ballafesson Farm Road)).
