HIGH COURT FEES ORDER 2002

Approved by Tynwald 18th June 2002

Coming into operation 5th August 2002

In exercise of the powers conferred on the Treasury by section 1 of the Fees and Duties Act 1989 (a), and of all other powers enabling it in that behalf, the following Order is hereby made:-

Citation and Revocation

1. (1) This Order may be cited as the High Court Fees Order 2002 and, subject to section 1(4) of the Fees and Duties Act 1989, shall come into operation on the 5th August 2002

(2) The High Court Fees Order 2000 (b) is revoked.

High Court Fees

2. The fees set out in column 2 of the Schedule shall be taken in the High Court in respect of the matters specified in column 1.
