**COMPANIES (TRANSFER OF DOMICILE) (FEES AND DUTIES)  
ORDER 2003**

*Laid before Tynwald 20<sup>th</sup> May 2003*

*Coming into operation 1<sup>st</sup> August 2003*

In exercise of the powers conferred on the Financial Supervision Commission by section 283A of the Companies Act 1931 (a), and of all other enabling powers, with concurrence of the Treasury the following Order is hereby made:-

**Citation and commencement**

1. This Order may be cited as the Companies (Transfer of Domicile) (Fees and Duties) Order 2003 and shall come into operation on 1<sup>st</sup> August 2003.

**Fees and Duties in respect of continued companies under Part 1 of the Companies (Transfer of Domicile) Act 1998**

2. The fees and duties set out in Part A of the Schedule shall be taken in the office for the registration of companies in respect of the matters specified in column 1 of that Schedule.

**Fees and Duties in respect of discontinued companies under Part 2 of the Companies (Transfer of Domicile) Act 1998**

3. The fees and duties set in Part B of the Schedule shall be taken in the office for the registration of companies in respect of the matters specified in column 1 of that Schedule.

**Fees and Duties in respect of applications to the Financial Supervision Commission under Part 1 and Part 2 of the Companies (Transfer of Domicile) Act 1998**

4. The fees and duties set out in Part C of the Schedule shall be paid to the Financial Supervision Commission in respect of the matters specified in column 1 of that Schedule.

**Revocation**

5. The Companies (Transfer of Domicile) (Fees and Duties) Order 2000 (b) is revoked.

1. For the registration of a memorandum of continuance under section 4 (2) of the Companies (Transfer of Domicile) Act 1998. £176.00
2. For each issue of any duplicate certificate of registration of the memorandum of continuance under section 4 (2) of the Companies (Transfer of Domicile) Act 1998. £11.00




1. For the filing of the instrument of continuance under section 10(2) of the Companies (Transfer of Domicile) Act 1998. £44.00
2. For each issue of any duplicate certificate of registration of the instrument of continuance under section 10(2) of the Companies (Transfer of Domicile) Act 1998. £11.00

**Part C**

1. For an application submitted under section 2(1) or section 8(1) of the Companies (Transfer of Domicile) Act 1998. £2,750.00
2. For each application where the Financial Supervision Commission is satisfied that:
  - (a) the applicant is a member of a group of companies;  
and
  - (b) another member of that group has made an application mentioned in entry 1 of this Part £1,100.00
