POST OFFICE ACT 1993

POST OFFICE (INLAND POST)(AMENDMENT) SCHEME 2003

Laid before Tynwald 8th April 2003

Coming into Operation 1st April 2003

In exercise of the powers conferred on the Isle of Man Post Office by Sections 13 and 59(2) of the Post Office Act 1993 (a) and all other enabling powers, and after consultation with the Department of Trade & Industry, the following Scheme is hereby made :-

Citation and commencement

1. This Scheme may be cited as the Post Office (Inland Post) (Amendment) Scheme 2003 and shall come into operation on 1st April 2003.

Amendments

2. The Isle of Man Post Office Authority (Inland Post) Regulations 1997 (b) (in this Scheme referred to as "the principal regulations") are amended in accordance with Schedule 1.

Revocations

3. The public documents mentioned in Schedule 2 are revoked to the extent specified in the third column of that Schedule.

EXPLANATORY NOTE

(This Note is not part of the Scheme)

1. This Scheme amends the Isle of Man Post Office Authority (Inland Post) Regulations 1977 by amending fees for postage due and redirection charges.
2. These changes take effect from 1st April 2003.
