



**FEEES AND DUTIES ACT 1989**

**HIGH COURT FEES ORDER 2004**

*Approved by Tynwald 16<sup>th</sup> March 2004*

*Coming into operation 1<sup>st</sup> May 2004*

In exercise of the powers conferred on the Treasury by section 1 of the Fees and Duties Act 1989 (a), and of all other powers enabling it in that behalf, the following Order is hereby made:-

**Citation and Revocation**

1. (1) This Order may be cited as the High Court Fees Order 2004 and, subject to section 1(4) of the Fees and Duties Act 1989, shall come into operation on the 1<sup>st</sup> May 2004
- (2) The High Court Fees Order 2002 (b) is revoked.

**High Court Fees**

2. The fees set out in column 2 of the Schedule shall be taken in the High Court in respect of the matters specified in column 1.
