**THE REGISTRATION OF BIRTHS, DEATHS AND MARRIAGES (FEES)
REGULATIONS 2004**

In exercise of the powers conferred on the Treasury by section 43(2) of the Civil Registration Act 1984¹ and section 51(2) of the Marriage Act 1984², and of all other enabling powers, the following Regulations are hereby made:—

1. Citation and commencement

These Regulations may be cited as the Registration of Births, Deaths and Marriages (Fees) Regulations 2004, and, subject to section 43(3) of the Civil Registration Act 1984 and section 51(3) of the Marriage Act 1984, shall come into operation on the 1st May 2004.

2. Fees

The fees payable under each of the enactments specified in column 1 of the Schedule in respect of the matters specified in column 2 shall be those specified in relation thereto in column 3.

3. Revocation

The following Regulations are revoked —

- (a) the Registration of Births, Deaths and Marriages (Fees) Regulations 1999³;


