



THE MEDICINES ACT 2003

THE MEDICINES (GENERAL SALES LIST) REGULATIONS 2005

Approved by Tynwald *17th January 2006*

Coming into operation *1st February 2006*

In exercise of the powers conferred on the Department of Health and Social Security by sections 2 and 52 of the Medicines Act 2003¹, and of all other enabling powers, the following Regulations are hereby made:—

1. Citation and Commencement

These Regulations may be cited as the Medicines (General Sales List) Regulations 2005 and shall come into operation on 1st February 2006.

2. Application of UK general sale list orders

The provisions of –

- (a) the Medicines (Products Other Than Veterinary Drugs) (General Sale List) Order 1984²;
- (b) the orders amending that Order specified in Schedule 1; and
- (c) any order made after the making of these Regulations and amending that Order,

being orders made under the provisions of the Medicines Act 1968 (an Act of Parliament)³ corresponding to section 2 of the Medicines Act 2003, shall apply to the Island subject to the modifications specified in Schedule 2.

3. Revocations

The Medicines (General Sales List) Order 1996⁴ is revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations apply to the Isle of Man the Medicines (Products Other Than Veterinary Drugs)(General Sale List) Order 1984 (SI 1984/769) as amended. That order specifies classes of medicinal products, which may be supplied otherwise than by or under the supervision of a pharmacist.

As permitted by section 52(3)(b) of the Medicines Act 2003, the Regulations apply future as well as past orders amending the 1984 Order.
