## **POST OFFICE ACT 1993**

### **POST OFFICE (INLAND POST) (AMENDMENT NO.1) SCHEME 2005**

**Laid before Tynwald: 19 – 21 April 2005**

**Coming into Operation: 7 April 2005**

In exercise of the powers conferred on the Isle of Man Post Office by Sections 13 and 59(2) of the Post Office Act 1993 (a) and all other enabling powers, and after consultation with the Department of Trade & Industry, the following Scheme is hereby made: -

#### **Citation and commencement**

1. This Scheme may be cited as the Post Office (Inland Post) (Amendment No.1) Scheme 2005 and shall come into operation on 7<sup>th</sup> April 2005.

#### **Amendments**

2. The Isle of Man Post Office Authority (Inland Post) Regulations 1977 (b) (in this Scheme referred to as "the principal regulations") are amended in accordance with Schedule 1.

#### **Revocations**

3. The public documents mentioned in Schedule 2 are revoked to the extent specified in the third column of that Schedule.

**EXPLANATORY NOTE**

(This Note is not part of the Scheme)

1. This Scheme amends the Isle of Man Post Office Authority (Inland Post) Regulations 1977 by -
  - (a) increasing the charges for posting a local letter and letters to the United Kingdom, the Channel Islands and the Irish Republic
  - (b) increasing the charges for posting local parcels
  - (c) increasing the fees for Freepost and Business Reply licences
  - (d) increasing the fees for the Temporary Retention/Keepsafe service
  - (e) increasing the Special Delivery and compensation fees
2. These changes take effect from 7<sup>th</sup> April 2005
