THE SOCIAL SECURITY ACT 2000  
THE SOCIAL SECURITY LEGISLATION (APPLICATION)  
(No. 2) ORDER 2005

*Approved by Tynwald*                      *20<sup>th</sup> April 2005*

*Coming into operation in accordance with Article 1*

In exercise of the powers conferred on the Department of Health and Social Security by section 1 of the Social Security Act 2000(a), and of all other enabling powers, the following Order is hereby made:-

**Citation and commencement**

1. (1) This Order may be cited as the Social Security Legislation (Application) (No. 2) Order 2005 and shall, subject to section 2(1) of the Social Security Act 2000, come into force as provided in paragraph (2).

(2) This Article and Articles 2 and 3 shall come into force forthwith and each provision of the applied legislation, as modified, shall be deemed to have come into force on the same day as that provision came into force in Great Britain.

**Interpretation**

2. (1) In this Order "the applied legislation" means the Social Security (Contributions) (Amendment) Regulations 2005(b).

(2) Unless the context otherwise requires –

- (a) any reference in any of the applied legislation to any provision in an instrument of a legislative character which is not itself a provision of any of the applied legislation shall be construed as if the provision so referred to had been in force in the Island from the date on which that instrument of a legislative character had effect in Great Britain;
- (b) reference in any legislation applied by this Order to any provision of any such legislation or of any other legislation applied to the Island by an order under section 1 of the Social Security Act 2000 or section 1 of the Pension Schemes Act 1995(a), shall be construed as a reference to that legislation as it has effect in the Island.

#### **Application to the Island of the applied legislation**

3. The applied legislation, as modified and shown in the Schedule to this Order, shall apply to the Island as part of the law of the Island.

### SOCIAL SECURITY

#### The Social Security (Contributions) (Amendment) Regulations 2005

##### Citation and commencement

1. (1) These Regulations may be cited as the Social Security (Contributions) (Amendment) Regulations 2005.

(2) These Regulations shall *be deemed to have* come into force on 6<sup>th</sup> April 2005.

##### Amendments to the Social Security (Contributions) Regulations 2001

2. The Social Security (Contributions) Regulations 2001 **(a)** are amended as follows.

3. Amend regulation 10 (earnings limits and thresholds) as follows -

- (a) for "2004" substitute "2005";
- (b) in paragraph (a) for "£79" substitute "£82";
- (c) in paragraph (b) for "£610" substitute "£630"; and
- (d) in paragraphs (c) and (d) for "£91" substitute "£94".

4. Amend regulation 11(3) (prescribed equivalents) as follows -

- (a) in paragraph (a) for "£395" substitute "£408"; and
- (b) in paragraph (b) for "£4,745" substitute "£4,895".

### EXPLANATORY NOTE

(This note is not part of the Order)

1. Section 1 of the Social Security Act 2000 enables the Department, by Order, to apply to the Island, as part of the law of the Island and incorporating such exceptions, adaptations and modifications as may be specified by the Order, any legislation to which that Act applies.
2. *Inter alia*, the Act applies to the Social Security Contributions and Benefits Act 1992 (an Act of the United Kingdom Parliament which has effect in the Isle of Man) and to any statutory instrument made or having effect as if made under that Act.
3. This Order applies to the Island the legislation referred to in Article 2(1) of the Order, the provisions of which are summarised in the following paragraphs. The applied legislation is deemed to have come into force on the same day as the corresponding provisions came into force in Great Britain. Where necessary, the provisions have been applied to the Island administratively pending their application by order.
4. **The Social Security (Contributions) (Amendment) Regulations 2005**
  - 4.1 These Regulations amend the Social Security (Contributions) Regulations 2001.
  - 4.2 Regulation 1 provides for the citation and commencement of the Regulations.
  - 4.3 Regulation 2 introduces the changes made to the principal Regulations.
  - 4.4 Regulation 3 amends regulation 10 of the principal Regulations to specify the levels of the lower and upper earnings limits for primary Class 1 contributions and the primary and secondary thresholds for primary and secondary Class 1 contributions for the tax year beginning 6<sup>th</sup> April 2005.
  - 4.5 Regulation 4 amends regulation 11(3) of the principal Regulations to provide for the equivalents of the primary and secondary thresholds where the earnings period is a month or a year.
