



ROAD TRAFFIC REGULATION ACT 1985

**BOROUGH OF DOUGLAS (VICTORIA STREET)  
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2005**

*Coming into Operation: 20<sup>th</sup> March 2005*

In exercise of the powers conferred on the Department of Transport by Section 3 of the Road Traffic Regulation Act 1985<sup>1</sup>, and of all other enabling powers, and after having complied with the procedure set out in Schedule 1 to the Act as required by Section 3(1), and having been satisfied that Section 1(8) of the Act does not apply, the following Order is hereby made:-

**1. Citation and commencement**

This Order may be cited as the Borough of Douglas (Victoria Street) (Temporary Prohibition of Through Traffic) Order 2005 and shall come into operation from 00.05 hours on Sunday 20<sup>th</sup> March 2005.

2) In this Order –

“the Act “ means the Road Traffic Regulation Act 1985; and

“the Department” means the Department of Transport

**2. Closure of road to vehicular traffic**

Subject to Article 3, no person shall, except upon the direction or with the permission of a constable in uniform, cause or permit any vehicle to proceed on that section of Victoria Street, Douglas, from its junction with Nelson Street to its junction with Duke Street.

**3. Exemption**

Article 2 does not apply to a vehicle requiring access to premises or land adjacent to the road specified in Article 2 or to –

(1) a vehicle engaged in any of the following operations –

(a) works in land or premises adjacent to the road specified in Article 2;

- (b) works in the road specified in Article 2 authorised by statutory provisions;  
or
  - (c) in the service of the Department or a local authority in pursuance of any statutory functions in the road or in adjacent land or premises if it cannot conveniently be used for such purposes on any other road; or
- (1) a vehicle being used in the course of duty for the police, fire brigade, ambulance or other emergency service; or
  - (2) a vehicle for which the driver holds a permit issued by the Department for its use in the road, at a time or for a purpose specified in the permit; or
  - (3) such vehicular traffic as may be authorised by the Department.

**4. Duration**

The Order shall continue in force from 00.05 hours until 23.55 hours on Sunday 20<sup>th</sup> March 2005 or until the demolition work is completed, whichever is the earlier.

**EXPLANATORY NOTE**

*(This note is not a part of the Order)*

The effect of this Order is to prohibit vehicular traffic from proceeding along a section of Victoria Street, in the Borough of Douglas, whilst demolition work is being undertaken.

An alternative route for traffic will be via Athol Street, Lord Street and Peveril Square.
