



ROAD TRAFFIC REGULATION ACT 1985

**LHARGAN/CRONK ROAD (PORT ST MARY)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2006**

Coming into Operation: 3 February 2006

In exercise of the powers conferred on the Department of Transport by Section 3 of the Road Traffic Regulation Act 1985¹, and of all other enabling powers, and after having complied with the procedure set out in Schedule 1 to the Act as required by Section 3(1), and having been satisfied that Section 1(8) of the Act does not apply, the following Order is hereby made:-

1. Citation and commencement

This Order may be cited as Lhargan/Cronk Road (Port St Mary) (Temporary Prohibition of Through Traffic) Order 2006 and shall come into operation at 6.00am on Friday 3 February 2006.

2) In this Order –

“the Act ” means the Road Traffic Regulation Act 1985; and

“the Department” means the Department of Transport

2. Closure of road to vehicular traffic

Subject to Article 3, no person shall, except upon the direction or with the permission of a constable in uniform, cause or permit any vehicle to proceed on that section of Lhargan/Cronk Road, Port St Mary between its junction with Bay View Road and its junction with Gellings Avenue.

3. Exemption

Article 2 does not apply to a vehicle requiring access to premises or land adjacent to the road specified in Article 2 or to –

(1) a vehicle engaged in any of the following operations –

(a) works in land or premises adjacent to the road specified in Article 2;

- (b) works in the road specified in Article 2 authorised by statutory provisions;
or
 - (c) in the service of the Department or a local authority in pursuance of any statutory functions in the road or in adjacent land or premises if it cannot conveniently be used for such purposes on any other road; or
- (2) a vehicle being used in the course of duty for the police, fire brigade, ambulance or other emergency service; or
 - (3) a vehicle for which the driver holds a permit issued by the Department for its use in the road, at a time or for a purpose specified in the permit; or
 - (4) such vehicular traffic as may be authorised by the Department.

4. Duration

The Order shall continue in force from 6.00am on Friday 3 February 2006 until 6.00pm on Friday 17 February 2006 or until the gas supply review work is completed, whichever is the earlier.

EXPLANATORY NOTE

(This note is not a part of the Order)

The effect of this Order is to prohibit vehicle traffic from proceeding along a section of Lhargan/Cronk Road, Port St Mary, whilst gas supply review work is being undertaken.

An alternative route will be via Bay View Road.

Access to the Bay View Hotel will be maintained.
