



ROAD TRAFFIC REGULATION ACT 1985

**PARLIAMENT STREET/BOURNE PLACE/PEEL STREET (RAMSEY)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2006**

Coming into Operation: 19 March 2006

In exercise of the powers conferred on the Department of Transport by Section 3 of the Road Traffic Regulation Act 1985¹, and of all other enabling powers, and after having complied with the procedure set out in Schedule 1 to the Act as required by Section 3(1), and having been satisfied that Section 1(8) of the Act does not apply, the following Order is hereby made:-

1. Citation and commencement

This Order may be cited as the Parliament Street/Bourne Place/Peel Street (Ramsey) (Temporary Prohibition of Through Traffic) Order 2006 and shall come into operation from 8.00am on Sunday 19 March 2006 and again from 6.00pm on Saturday 25 March 2006.

2) In this Order –

“the Act ” means the Road Traffic Regulation Act 1985; and

“the Department” means the Department of Transport

2. Closure of road to vehicular traffic

Subject to Article 3, no person shall, except upon the direction or with the permission of a constable in uniform, cause or permit any vehicle to proceed on that section of Parliament Street/Bourne Place/Peel Street, Ramsey, from its junction with Bowring Road to its junction with Albert Street.

3. Exemption

Article 2 does not apply to a vehicle requiring access to premises or land adjacent to the road specified in Article 2 or to –

(1) a vehicle engaged in any of the following operations –

(a) works in land or premises adjacent to the road specified in Article 2;

- (b) works in the road specified in Article 2 authorised by statutory provisions;
or
 - (c) in the service of the Department or a local authority in pursuance of any statutory functions in the road or in adjacent land or premises if it cannot conveniently be used for such purposes on any other road; or
- (1) a vehicle being used in the course of duty for the police, fire brigade, ambulance or other emergency service; or
 - (2) a vehicle for which the driver holds a permit issued by the Department for its use in the road, at a time or for a purpose specified in the permit; or
 - (3) such vehicular traffic as may be authorised by the Department.

4. Duration

The Order shall continue in force from 8.00am on Sunday 19 March 2006 until 5.00pm on Sunday 19 March 2006 and again from 6.00pm on Saturday 25 March 2006 until 5.00pm on Sunday 26 March 2006 or until the roadworks are completed, whichever is the earlier.

EXPLANATORY NOTE

(This note is not a part of the Order)

The effect of this Order is to prohibit vehicular traffic from proceeding along a section of Parliament Street, Bourne Place and Peel Street, Ramsey, whilst roadworks are being undertaken.
