



ROAD TRAFFIC REGULATION ACT 1985

**GLEN MOOAR LOOP ROAD (GERMAN)  
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2007**

*Coming into operation: 15 January 2007*

In exercise of the powers conferred on the Department of Transport by Section 3 of the Road Traffic Regulation Act 1985<sup>1</sup> and of all other enabling powers, and after having complied with the procedure set out in Schedule 1 to the Act as required by Section 3(1) and after having been satisfied that Section 1(8) of the Act does not apply, the following Order is hereby made:-

**1. Citation and commencement**

(1) This Order may be cited as the Glen Mooar Loop Road (German) (Temporary Prohibition of Through Traffic) Order 2007 and shall come into operation at 6.00am on Monday 15 January 2007.

(2) In this Order –

“the Act” means the Road Traffic Regulation Act 1985; and

“the Department” means the Department of Transport.

**2. Closure of road to vehicular traffic**

Subject to Article 3, no person shall except upon the direction or with the permission or a constable in uniform, cause any vehicle to proceed on that section of the Glen Mooar Loop Road between its junction with the Brack-e-Broom Road and a point adjacent to the entrance to the property known as Ballachrink Lodge.

**3. Exemptions**

Article 2 does not apply to a vehicle requiring access to premises or land adjacent to the road specified in Article 2 or to –

(1) a vehicle engaged in any of the following operations:

(a) works in land or premises adjacent to the road specified in Article 2;

(b) works in the road specified in Article 2 authorised by statutory provisions;  
or

- (c) in the service of a local authority or the Department of Transport in pursuance of any statutory functions in the road or in adjacent land or premises if it cannot conveniently be used for such purposes on any other road; or
- (2) a vehicle being used in the course of duty for the police, fire brigade, ambulance or coastguard service: or
- (3) a vehicle for which the driver holds a permit issued by the Department of Transport for its use in the road, at a time or for a purpose specified in the permit; or
- (4) such vehicular traffic as may be authorised by the Department.

#### **4. Duration**

The Order shall continue in force from 6.00am on Monday 15 January 2007 until 6.00pm on Saturday 20 January 2007 or until the culvert renewal work is completed, whichever is the earlier.

#### **EXPLANATORY NOTE**

*(This note is not a part of the Order)*

The effect of this Order is to prohibit vehicular traffic from proceeding along a section of the Glen Moar Loop Road, in the Parish of German, whilst culvert renewal work takes place.

An alternative route will be via the Tynwald Hill to Poortown Road.
