



ROAD TRAFFIC REGULATION ACT 1985

**BOROUGH OF DOUGLAS (QUEEN STREET)
(TEMPORARY PROHIBITION OF THROUGH TRAFFIC) ORDER 2007**

Coming into Operation: 17 January 2007

In exercise of the powers conferred on the Department of Transport by Section 3 of the Road Traffic Regulation Act 1985¹, and of all other enabling powers, and after having complied with the procedure set out in Schedule 1 to the Act as required by Section 3(1), and having been satisfied that Section 1(8) of the Act does not apply, the following Order is hereby made:-

1. Citation and commencement

This Order may be cited as the Borough of Douglas (Queen Street) (Temporary Prohibition of Through Traffic) Order 2007 and shall come into operation from 6.00am on Wednesday 17 January 2007.

2) In this Order –

“the Act ” means the Road Traffic Regulation Act 1985; and

“the Department” means the Department of Transport

2. Closure of road to vehicular traffic

Subject to Article 3, no person shall, except upon the direction or with the permission of a constable in uniform, cause or permit any vehicle to proceed on that section of Queen Street, Douglas, between its junction with North Quay and a point abutting the north-western boundary of the Saddle Hotel.

3. Exemption

Article 2 does not apply to a vehicle requiring access to premises or land adjacent to the road specified in Article 2 or to –

(1) a vehicle engaged in any of the following operations –

(a) works in land or premises adjacent to the road specified in Article 2;

(b) works in the road specified in Article 2 authorised by statutory provisions;
or

(c) in the service of the Department or a local authority in pursuance of any statutory functions in the road or in adjacent land or premises if it cannot conveniently be used for such purposes on any other road; or

- (2) a vehicle being used in the course of duty for the police, fire brigade, ambulance or other emergency service; or
- (3) a vehicle for which the driver holds a permit issued by the Department for its use in the road, at a time or for a purpose specified in the permit; or
- (4) such vehicular traffic as may be authorised by the Department.

4. Suspension of Temporary One-Way Order

The provisions of paragraph 28 of the Borough of Douglas One Way Traffic Streets Order 1981² as it relates to Queen Street shall cease to have effect for the duration of this Order.

5. Duration

The Order shall continue in force from 6.00am on Wednesday 17 January 2007 until 6.00pm on Monday 5 March 2007 or until the roof and exterior wall remedial works are completed, whichever is the earlier.

EXPLANATORY NOTE

The effect of this Order is to prohibit vehicular traffic from proceeding along a section of Queen Street, Douglas, whilst roof and exterior wall remedial works are being undertaken.
