**POST OFFICE ACT 1993  
POST OFFICE (INLAND POST) (AMENDMENT NO.1) SCHEME 2007**

**Laid before Tynwald: 17<sup>th</sup> April 2007**  
**Coming into Operation: 2<sup>nd</sup> April 2007**

In exercise of the powers conferred on the Isle of Man Post Office by Section 13 of the Post Office Act 1993 (a) and all other enabling powers, and after consultation with the Department of Trade & Industry, the following Scheme is hereby made :-

**Citation and commencement**

1. This Scheme may be cited as the Post Office (Inland Post) (Amendment No.1) Scheme 2007 and shall come into operation on 2<sup>nd</sup> April 2007.

**Amendments**

2. The Isle of Man Post Office Authority (Inland Post) Regulations 1977 (b) (in this Scheme referred to as "the principal regulations") are amended in accordance with Schedule 1.

**Revocations**

3. The public documents mentioned in Schedule 2 are revoked to the extent specified in the third column of that Schedule.

**EXPLANATORY NOTE**

(This Note is not part of the Scheme)

1. This Scheme amends the Isle of Man Post Office Authority (Inland Post) Regulations 1977 by -
  - (a) Increasing the charges for posting Large Letters and Packets within the Isle of Man and to the United Kingdom & the Channel Islands;
  - (b) Increasing the fees for Freepost & Business Reply Licences, Recorded Delivery, Private Boxes, Redirection of Mail and Temporary Retention/Keepsafe; and
  - (c) Increasing the Special Delivery fees.
  
2. These changes take effect from 2<sup>nd</sup> April 2007.
