**POST OFFICE ACT 1993
POST OFFICE (OVERSEAS LETTER POST) (AMENDMENT NO.1) SCHEME 2007**

**Laid before Tynwald: 17th April 2007
Coming into Operation: 2nd April 2007**

In exercise of the powers conferred on the Post Office by Sections 13 and 59(2) of the Post Office Act 1993 (a) ("the Act") and of all other enabling powers, and after consultation with the Department of Industry, the following Scheme is hereby made:-

Citation and commencement

1. This Scheme may be cited as the Post Office (Overseas Letter Post) (Amendment No.1) Scheme 2007 and shall come into operation on 2nd April 2007.

Amendments of the principal Regulations

2. The Isle of Man Post Office Authority (Overseas Letter Post) Regulations 1977 (b) (in this Scheme referred to as "the principal Regulations") are further amended in accordance with Schedule 1.

Revocations

3. The public documents mentioned in Schedule 2 are revoked to the extent specified in the third column of that Schedule.

(This Note is not part of the Scheme)

This Scheme further amends the Isle of Man Post Office Authority (Overseas Letter Post) Regulations 1977 (GC No. 113/77 as amended) by revising the postage charges on surface letters, airmail letters, postcards, printed papers and small packets sent to destinations in Europe and worldwide and fees for insured letters.
2. The revised postage charges and fees take effect from 2nd April 2007.
