# LIBYA SANCTIONS (AMENDMENT) REGULATIONS 2015

*Laid before Tynwald: 21 April 2015*  
*Coming into Operation in accordance with regulation 2*

The Council of Ministers makes the following Regulations under sections 2B and 2C of the European Communities (Isle of Man) Act 1973.

## 1 Title

These Regulations are the Libya Sanctions (Amendment) Regulations 2015.

## 2 Commencement

These Regulations come into operation immediately after they are made.

## 3 Amendment of the Libya Sanctions Regulations 2011

(1) The Libya Sanctions Regulations 2011<sup>1</sup> are amended as follows.

(2) In regulation 3, for the definition of the “EU Regulation” substitute —

“the EU Regulation” means Council Regulation (EU) No 204/2011<sup>2</sup> of 2 March 2011 concerning restrictive measures in view of the situation in Libya, as amended by —

- (a) Council Regulation (EU) No 296/2011<sup>3</sup> of 25 March 2011 amending Regulation (EU) No 204/2011 concerning restrictive measures in view of the situation in Libya;
- (b) Council Implementing Regulation (EU) No 360/2011<sup>4</sup> of 12 April 2011 implementing Article 16(1) and (2) of Regulation (EU) No 204/2011 concerning restrictive measures in view of the situation in Libya;

- (c) Council Implementing Regulation (EU) No 502/2011<sup>5</sup> of 23 May 2011 implementing Regulation (EU) No 204/2011 concerning restrictive measures in view of the situation in Libya;
- (d) Council Regulation (EU) No 572/2011<sup>6</sup> of 16 June 2011 amending Regulation (EU) No 204/2011 concerning restrictive measures in view of the situation in Libya;
- (e) Council Implementing Regulation (EU) No 573/2011<sup>7</sup> of 16 June 2011 implementing Article 16(2) of Regulation (EU) No 204/2011 concerning restrictive measures in view of the situation in Libya;
- (f) Council Implementing Regulation (EU) No 804/2011<sup>8</sup> of 10 August 2011 implementing Regulation (EU) No 204/2011 concerning restrictive measures in view of the situation in Libya;

- (k) Council Regulation (EU) No 1139/2011<sup>13</sup> of 10 November 2011 amending Regulation (EU) No 204/2011 concerning restrictive measures in view of the situation in Libya;
- (l) Council Regulation (EU) No 1360/2011<sup>14</sup> of 20 December 2011 amending Regulation (EU) No 204/2011 concerning restrictive measures in view of the situation in Libya;

- (m) Council Regulation (EU) No 488/2013<sup>15</sup> of 27 May 2013 amending Regulation (EU) No 204/2011 concerning restrictive measures in view of the situation in Libya;
- (n) Council Regulation (EU) No 45/2014<sup>16</sup> of 20 January 2014 amending Regulation (EU) No 267/2012 concerning restrictive measures in view of the situation in Libya;
- (o) Council Regulation (EU) No 690/2014<sup>17</sup> of 23 June 2014 amending Regulation (EU) No 204/2011 concerning restrictive measures in view of the situation in Libya;
- (p) Council Regulation (EU) No 1102/2014<sup>18</sup> of 20 October 2014 amending Regulation (EU) No 204/2011 concerning restrictive measures in view of Libya; and
- (q) Council Regulation (EU) No 2015/374<sup>19</sup> of 6 March 2015 amending Regulation (EU) No 204/2011 concerning restrictive measures in view of Libya,

as these instruments have effect in the Island<sup>20</sup>, and a reference to a numbered Article or Annex (without more) is a reference to the Article of, or Annex to, the EU Regulation so numbered. **22**.

#### 4 Revocation

The Libya Sanctions (Amendment) (No.3) Regulations 2014<sup>21</sup> are revoked.

***EXPLANATORY NOTE******(This note is not part of the Regulations)***

These Regulations amend the Libya Sanctions Regulations 2011 (SD 158/11: “the principal Regulations”) to take account of the amendment of Council Regulation (EU) No 204/2011 by Council Regulation (EU) 2015/374 as these EU instruments have effect in the Island by virtue of SD 157/11 (with previous amendments) and SD 2015/0126 respectively.

The principal Regulations established offences and penalties for breaches of Council Regulation (EU) No 204/2011, as applied to the Island by SD 157/11, and they provided for the licencing by Treasury of activities which would otherwise be proscribed.
