# TYNWALD COMMISSIONER FOR ADMINISTRATION ACT 2011 (APPOINTED DAY) (NO.1) ORDER 2017

Made: 6 June 2017 Laid before Tynwald: 20 June 2017

The Council of Ministers makes the following Order under section 2 of the Tynwald Commissioner for Administration Act 2011.

#### 1 Title

This Order is the Tynwald Commissioner for Administration Act 2011 (Appointed Day) (No.1) Order 2017.

### 2 Commencement of provisions of Tynwald Commissioner for Administration Act 2011

- (1) Provisions of the Tynwald Commissioner for Administration Act 2011 come into force in accordance with paragraphs (2) to (5) below.
- (2) The following provision, namely
  - (a) section 3; and
  - (b) paragraphs 1(1) and 4 of Schedule 1 and section 4(4) to the extent that it gives effect to those paragraphs,

come into operation on 12 June 2017 so far as is necessary for the Selection Committee to determine the terms and conditions of appointment of the Commissioner.

- (3) The following provisions, namely—
  - (a) section 3 to the extent it is not already in operation;
  - (b) section 4 to the extent it is not already in operation;
  - (c) in section  $30^{1}$ 
    - (i) subsection (1),

- (ii) subsection (3) to the extent that it inserts paragraph (ic) into section 3(2) of the Personal Liability (Ministers, Members and Officers) Act 2007; and
- (iii) subsection (5)<sup>2</sup>, and
- (d) Schedule 1 to the extent it is not already in operation, other than paragraphs 3(3) and 12,

come into operation on 1 July 2017.

- (4) The remainder of the Act, comes into operation on 31 December 2017 other than
  - (a) section 29;
  - (b) section 30(3) to the extent that inserts paragraph (id) into section 3(2) of the Personal Liability (Ministers, Members and Officers) Act 2017;
  - (c) in Schedule 1, paragraphs 3(3) and 12;
  - (d) in Schedule 2, paragraph 1(b) to (l).
- (5) This article is subject to article 3 (transitionals and savings).

#### 3 Transitionals and savings

- (1) Until the coming into operation of the Tynwald Auditor General Act 2011, Schedule 1 is modified by
  - (a) the omission in paragraph 3(1)(d) of "(other than the Tynwald Auditor General)"; and
  - (b) the omission in paragraph 6(1)(b) of "(other than that of Tynwald Auditor General)".
- (2) Until the coming into operation of paragraph 12 of Schedule 1 (Commissioner's staff), the reference in paragraph 14(1)(a) of that Schedule to a member of the Commissioner's staff is to be read as a reference to
  - (a) any member of the staff of the Clerk of Tynwald; or
  - (b) any member of the staff of a partnership or body corporate of which the Commissioner is a partner or director (or equivalent),

assisting the Commissioner in the performance of the Commissioner's functions.

(3) Until the coming into operation of subparagraphs (a) to (l) of paragraph 1 of Schedule 2, for paragraph 2 of that Schedule there is substituted—

"A person is also a listed authority if he or she is for the time being specified in subsection (2)(b), (f) or (g) of section 3 of the *Personal Liability* (*Members, Ministers and Officers*) *Act* 2007.".
