MATERNITY AND FUNERAL EXPENSES (GENERAL) (ISLE OF MAN) (AMENDMENT) REGULATIONS 2019

*Approved by Tynwald: 19th February 2019
Coming into Operation in accordance with regulation 2*

The Treasury makes the following Regulations under sections 138 and 175 of the Social Security Contributions and Benefits Act 1992¹ as it has effect in the Island².

1 Title

These Regulations are the Maternity and Funeral Expenses (General) (Isle of Man) (Amendment) Regulations 2019.

2 Commencement

If approved by Tynwald, these Regulations come into operation on 8 April 2019³.

3 Amendment of the Maternity and Funeral Expenses (General) (Isle of Man) Regulations 2007

The Maternity and Funeral Expenses (General) (Isle of Man) Regulations 2007⁴ are amended as follows.

4 Regulation 5 amended

In regulation 5⁵ (entitlement: maternity payments), in paragraph (5)—

- (a) in sub-paragraph (a) for “£250” substitute **£300**; and
- (b) in sub-paragraph (b) for “£500” substitute **£600**.

5 Regulation 11 amended

- (1) Regulation 11⁶ (the amount of a funeral payment) is amended as follows.
- (2) In paragraph (3) —
 - (a) in sub-paragraph (g) for “£140” substitute “£145”;
 - (b) in sub-paragraph (h) for “£52” substitute “£55”; and
 - (c) in sub-paragraph (i) for “£1,350” substitute “£1,400”.
- (3) In paragraph (7)(b) for “£1,350” substitute “£1,400”.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Maternity and Funeral Expenses (General) (Isle of Man) Regulations 2007 (“the Maternity and Funeral Expenses Regulations”).

The changes made increase the amount of maternity payments payable under the Maternity and Funeral Expenses Regulations.

They also increase the maximum amount in respect of certain funeral costs (minister’s fee, organist’s fee and any other funeral expenses not specifically mentioned in the Maternity and Funeral Expenses Regulations) which qualify as relevant expenditure for which a funeral payment is payable under those Regulations.
